  - a. Fatal & Serious Injury Scoreboard. BoYan will work with Cindy Stewart to review current reports and what data would be most interesting to the STRAC.

  - e. BESDT Dashboard. have some feedback on functionality, data requests can make data requests through another site; CORA requests gov agency probably does not need to make CORA request others probably do. CDPHE interested in being kept in the loop. They created and update the public CDOT Problem ID dashboard, using crash data, and the CDPHE public injury dashboard, that includes motor vehicle-related deaths, hospitalizations, and emergency visits.

- Specific near-term groups (next 6 months) include AAA (Skyler McKinley), Metro Area Traffic Engineers, and GDAB
- iv. Glenn Davis and Emily Kleinfelter agreed to reach out to Skyler as a starting point. TRC will

assist with meeting support.

- Will build a general outreach presentation that includes information on the STRAC, scoreboard, mission/vision/goals, and contact-specific information (what is the ask / offer for each group?)

Potential Outreach Candidates by Traffic Records System

- v. University partnerships were another outreach candidate that was discussed.
  - The conversation associated with this outreach effort included Personally Identifiable Information (PII), vehicle telematics data, and data to connect vehicle equipment and safety performance.
  - This outreach effort is planned to occur after the initial AAA outreach and potential refinements / adjustments to the approach.
- vi. Outreach to local law enforcement would support many STRAC efforts, including potentially
  - E-Citation
  - · Investigating Officers Crash Reporting Manual
  - Police associations RE: vulnerable road users
  - This is a calendar year 2023 outreach effort
- vii. Neighboring states and similar states
  - · Build off Go Team connection to Nevada
  - NHTSA Region 8 states
  - · Similar states incl. Washington, Minnesota, Louisiana, Mississippi and Missouri
  - 4 Corner Conference in September
  - ATSIP

#### viii. Policy makers

- · Work through legislative liaisons
- Invite to STRAC meetings
- Need to start 18 months out

- viii. Expand partnership with law enforcement (by June 2023)
