- 4. Southwest Chief & Front Range Passenger Rail Jacob Riger / TIGER 9 Jim Souby, Pete Rickershauser, & Rob Eaton / CRISI Sharon Terranova & David Krutsinger (attachment)
  - One provision SB1 / 2.5M Service Planning, scope of services for consulting, staffing (project manager), and a year of funding.
  - Discussion regarding widening gap (I-25 project). Right around first of July this project will start this project affects the layout of the railway.
  - TIGER9 up in the air as Amtrak has placed conditions on this, but would like to hear what update Rob Eaton might have on this. There has been previous work already completed.
  - Rob Eaton noted the landscape is changing on a daily basis. Currently, no additional updates. He has a call in to Ray Lang trying to get an update for the next meeting on the 30<sup>th</sup>, noting there is a changing environment and hopes to have an update for the next meeting.
  - Pete Rickershauser noted BNSF commitment, will live by the cash commitment to install and pay for all the other work.

## 7. State Management Review Update – Brodie Ayers

- Every 3 years the Site Management Review is completed
- Site Reviews take approximately 1/2 day to complete with an After Action Report assisting us to move forward Areas and other programs involved include
  - Technical reports
  - Civil rights
  - Milestones
  - Program measurements
  - Processes & training
- State Management Plan also included which includes processes and procedures that is completed

## 8. Consolidated Capital Call for Projects Recommendations – Jeff Sanders (attachment)

- November 2017 issued a Notice of Funding Availability (NOFA) to state and local government authorities, nonprofit organizations, operators of public transportation or intercity bus service, and other transit groups for transit capital projects that are eligible for funding through federal and state programs that CDOT administers.
- Over 60 applications totaling over \$30 million in grant requests \$13 million available to build or rehab facilities

#### 9. State Transit Plan RFP – Jeff Sanders (attachment)

- Writing the RFP to obtain the assistance of a Consultant.
- One of the first things is create a steering committee including TRAC Members, will be a two-year effort.
- Joint COPIRG document is a part of this, benefit with a part of this, will help the document to speak in a louder way.

Danny Katz noted that the Plan could learn a lot from the Transit Development piece, where do we go and how do we move, the formula tries to provide how we value different parts of the state, try to incorporate different parts of the state, here is why different parts of the state get more and here is why. Incorporate that as much as you can. Jeff Sanders noted as soon a project is listed the projects change, do you just list strategies, or challenges. The Statewide Transit Plan will be a more high level needs. David Krutsinger added, are we using the budget right, how does the system work, are we making Bustang fit right, where are we going how should we spend the money, what are the critical pieces? Danny Katz said what we have a hard time articulating is I find plans more helpful and that is where a group like mine can use it. Bill Van Meter added that transit is very hard right now changes so hard. Danny Katz asked if a scenario plan is possible for the Plan. Jacob Riger noted that is essentially what mobility choice is doing, a blueprint plan – what does that actually mean for partnerships, how to engage, it started beginning of this year. Bill Van Meter asked if it was possible to develop different scenarios on potential technical change and impacts in the Denver metro area transferrable to the state helping all agencies aligned with statewide investments. David Krutsinger added that maybe for the next meeting in July we could have an agenda item for this topic and discussion around that for the Statewide Transit plan.
