- Matthew Helfant: last meeting announcement
- Amber Blake: congratulations to Matthew. Announced this is her last meeting / 17th March last day
 o moving on to consulting firm
- David A: thank you to Amber Blake/ positioning of SMART as lead agency for gondola work/ funding for operations end in 2027
- Will Jones: congrats to Amber Blake
- Danny Katz: "Denver moves everyone plan"/ vision of 5 BRT routes for 2030 list/ looking forward to Denver taking initiative
- Ann R.: thanks to Amber Blake as DTR director
- Will Jones: election of officers next meeting
 - o Amber B. question about Will's role
 - Will says his position will be filled
 - Amber B asks: transit manager filling rest of term?
 - Will answers that it is undecided
 - Matthew Helfant seat being taken by Alvan Bidal Sanchez temporarily

3. Bustang Update – Jennifer Phillips

- Ridership update/ shows depth of routes/ I-70 is doing very well/ all routes are up from 2019/ moved 170k passengers in 2022
- South and North lines are more impact by work from home shifts in workforce
- Outrider program
 - o new Sterling/Greeley/Denver route launched and Pueblo to Trinidad route launching in March
- Outrider ridership update
 - o changed graph parameters
 - o Telluride is of concern
 - better connections needed etc.
 - hopefully will improve ridership since working with operators
 - o focusing on marketing with Sterling/Greeley/Denver route/ slow start
 - Pegasus route is doing well
 - expansion in September 2022 and schedule modification (new schedule now live)
 - eliminated many overnights in Avon due to operator complaint
 - Bustang to Broncos
 - north and south lines successful
 - weak ridership on west line so not continuing in 2023
 - o Snowstang
 - doing very well / new Breckenridge line is very successful
- partnering with a group focusing on diversifying the mountains / group is Slide Through Saturdays
 - o free lift tickets and equipment provided by resorts and businesses
 - O CDOT/ Snowstang provides transportation to ski resorts
 - Jennifer presented video highlighting this group's previous event
- Elkstang announcement
 - o Estes Park seasonal service
 - o active May through October
- Bustang expansion study
 - o study should be done end of June or early July
- outrider funding now in NOFA

- Connected Colorado Project
 - o contract negotiations/ 4 partners/ changes ticketing systems
- electrification study working with OIM
- vehicle purchases/ 5 buses on order currently
- questions:
 - Eva Wilson: excited to see ridership on west I70/ concern with people with being left at curb due to lack of space on buses
 - Eva: reservation system starting with Bustang?
 - Jennifer: Possible 50/50 split with reservation with on-demand seating
 - Eva: difference between Bustang versus Snowstang reservation system?
 - Jennifer: stems from different purposes/ some services are limited throughout year
 - Eva: are there incentives for getting coach operators
 - Jennifer: Ace operator contract means they are responsible for providing operators
 - Ace created program for Pegasus drivers to get CDL to drive coach/ pipeline for more in-demand routes
 - CDOT is looking at leadership role to possibly take to promote CDL operators statewide
 - o Sarah Curtis in Montrose: pleased to hear exploring more schedules/ offered help
 - O David Johnson/ when is electrification study beginning?
 - Jennifer: RFP will be issued within a month for contractor to complete study (so soon)
 - David: comments to keep in mind that we are overhauling our facility so open to Bustang 'fueling' given results of EV study/ new facility operable in 2025
 - O Jonathan Flint: fleet electrification are hybrid options on the table?
 - Jennifer: refers to study that will be completed and she will follow up
