   department decisions
- Procedural Directives are adopted by the Executive Director
- Specifies how goals and department decisions are to be implemented

- Originate from any CDOT office/branch
- Set policy for a program or process
- Establish procedures, processes or guidance/guidelines
- Establish goals and objectives
- Provide direction to the Department

# TC "Policy" Resolutions

- Set policy or guidance, but are adopted by the TC as a resolution rather than a policy directive
- Often get updated by a new resolution
- Examples:
  - Establishment of a Congestion Relief Program
  - Interstate Corridor Vision Guidance
  - Tolling Policies (former CTE)
  - Revenue Allocation Methodology

## TC Approved Guidance

- Prepared in response to TC Policy Directives or Resolutions
- Further support policy
- Examples:
  - Planning Policy Guidance
  - Congestion Relief Guidelines
  - 4P and STIP Development Guidelines
