Failure to complete this application and provide all applicable exhibits will result in the application not being processed.

Part 1: Applicant information, sign specification

- Sign Owner Name – individual, business, trust, etc. that owns the sign
- Mailing Address – number and street mailing address of sign owner
- City, State, ZIP – city, state and ZIP for mailing address
- Phone – phone number of sign owner
- E-mail – e-mail of sign owner
- Sign Operator Name and Phone – party responsible for operating the sign
- Emergency Contact Name and Phone – CDOT should contact in case of emergency, such as falling sign or other hazardous condition.
- Property Owner Name – on whose property the sign resides
- Mailing Address – of property owner
- City, State, ZIP – of property owner
- Phone – property owner
- E-mail – property owner
- Purpose of Application – check one of the boxes for “Static Sign” or for “Changeable Electronic Variable Message Sign (CEVMS)”
- How many sign faces will your sign have? – provide the number of sign faces
- Sign(s) is(are) facing – if the sign is facing toward the east, select east; toward the west, select west; etc
- Exhibit A – check this box if the sign owner is a business, and attach a copy of the Secretary of State certificate of good standing
- Exhibit B – check this box if you obtained local jurisdiction certification for zoning documents you obtained, and attach a copy of the zoning documents with the certification

- Exhibit F – check this box and attach a copy of architectural or engineered drawings of the sign structure and provide operation specifications if the sign is a CEVMS; if no architectural or engineered drawings exist, include plan and elevation drawings along with photos or renderings of the sign
- Sign Dimensions – provide the height, length and area of the sign face, and provide the height of the sign structure from ground to top of sign

- Sign Location –
 - Provide the longitude, latitude and GPS datum (if applicable) of the sign.
 - If this information was obtained by a surveyor, provide the surveyor’s Colorado registration number (under Surveyor).
 - For “Distance to Nearest CEVMS,” provide the distance (in feet) to the nearest permitted CEVMS that is situated ahead or behind of the proposed CEVMS location on the same side of the highway.
 - For Spacing Along Highway (Ahead), provide the distance (in feet) to the nearest permitted Off-Premise sign that is situated ahead of the proposed sign location on the same side of the highway.
 - For Spacing Along Highway (Behind), provide the distance (in feet) to the nearest permitted Off-Premise sign that is situation behind the proposed sign location on the same side of the highway.
 - Finally, check the appropriate Kerr or Cotton box if the sign resides in a Kerr area or Cotton area as defined in 2 CCR 601-3(7.00)(A)(2).

- Distance from ROW – the distance of the sign from the nearest edge of the highway right-of-way
