## **Key SW Chief and Front Range Passenger Rail Commission Staff Activities**

- Finalize and distribute March 27 Rail Commission meeting draft minutes and April 24 agenda packet.
- Participated in a call with several Rail Commission members to discuss possible "bill language" for potential passenger rail related projects in Colorado for upcoming Stimulus and federal Transportation Re-Authorization bills.
- Worked with CDOT Office of Communications and Consultant Project team staff in drafting COVID-19 messaging document related to Front Range Passenger Rail Project.
- Worked with SW Chief Grant partners in Colorado, Kansas and New Mexico in developing pledge commitments for 2020 Build Grant for completion of SW Chief Infrastructure improvements in the three states.
- Conference call with CDOT Region and Headquarters Environmental staff to discuss Front Range Passenger rail Project.
- Participated in conference call (3<sup>rd</sup> Coordination meeting) with FRA, FTA and FHWA regarding Front Range Passenger Rail

- Held "on-line interviews" with Fort Carson, to get their perspectives on Front Range Passenger Rail. Attempting to set such interviews with Denver international Airport, Colorado Motor Carriers, Action 22, and E-470.
- Set May 4 meeting with BNSF Railway and Union Pacific railroad to discuss possible use of freight rail Corridors for elements of Front Range Passenger Rail. Also, scheduling similar meeting with RTD.
- Prepared for upcoming "Round 3" of Segment Stakeholder Coalition meetings to be held April 28, 29, and 30.
- Participated on a monthly conference call with members of the States for Passenger Rail Coalition. Also,
  provided them information about SW Chief Thru-car Service to Pueblo/Colorado Springs feasibility Study and
  also Front Range Passenger Rail Project for their use in pursuing Stimulus and Re-Authorization Funding from
  Congress.
