Key SW Chief and Front Range Passenger Rail Commission Staff Activities

- Finalize and distribute September 25th Commission meeting draft minutes and October 23rd agenda packet.
- Submitted Final Statement of Work to FRA for Thru-car Alternatives Analysis. Schedule and Budget have been approved. Working with CDOT Procurement to initiate RFP process. Met with 3 consulting teams in advance of release of RFP. Obligation of Grant agreement expected soon.
- Rail Commission staff notified that 2020 CRISI Grant application had been approved. Kick-off meeting being scheduled for late October. This \$548,000 federal Grant, and the \$137,000 in non-federal matching funds, will complete preliminary Rail Passenger Service Development Planning and Rail Simulation Modeling. These are critical steps prior to the FRPR Project entering into NEPA.
- Round 4 of Segment Stakeholder Coalition meeting summaries distributed.
