

Resolution #TC-2022-07-04

Providing approval for the 2022 legislative session five memorial designations of state highways.

Approved by the Transportation Commission on July 21, 2022

WHEREAS, TC Policy Directive 1503.0 establishes a consistent statewide process regarding designation or memorializing of highways, bridges or other highway components, and;

WHEREAS, All legislative memorial designations allow CDOT to accept gifts, grants and donations for the installation of these signs. As such, no state funds will be used to produce, erect, or install these signs, and;

WHEREAS, House Joint Resolution 22-1014 passed designating the portion of State Highway 21 from Kettle Creek to Woodmen Road in El Paso County as the "SFC Will Lindsay Memorial Highway" in honor of Sergeant First Class Will Lindsay's lifetime of honorable service and heroic sacrifice, and;

WHEREAS, House Joint Resolution HJR 22-1015 passed designating the portion of Colorado State Highway 115 from Mile Marker 42 to Mile Marker 43 be designated as the "CW3 Scott A. M. Oswell Memorial Highway", and;

WHEREAS, House Joint Resolution HJR 22-1018 passed designating the portion of Colorado State Highway 14 in Weld County from Mile Marker 153 to Mile Marker 154 be designated as the "Colonel Stan Cass Memorial Highway", and;

WHEREAS, House Joint Resolution HJR 22-1019 passed designating the portion of Colorado State Highway 85 from the intersection of Colorado State Highway 85 and 1st Street in Ault to the intersection of Colorado State Highway 85 and E Main Avenue in Pierce be designated as the "Pvt. Joe P. Martinez Memorial Highway", and,

WHEREAS, Senate Joint Resolution SJR 22-012 passed designating The of Colorado State Highway 115 in Fremont County from Mile Marker 15 to Mile Marker 27 be designated as the "Veterans of Foreign Wars Warriors Memorial Highway",

WHEREAS, CDOT staff recommends the Transportation Commission approve the four proposed project match rate reductions as presented.

NOW THEREFORE BE IT RESOLVED, that the Colorado Transportation Commission approves state highway memorial designations the Colorado General Assembly passed during the 2022 general legislative session:

- SFC Will Lindsay Memorial Highway
- CW3 Scott AM Oswell Memorial Highway
- Colonel Stan Cass Memorial Highway
- Pct. Joe P Martinez Memorial Highway
- Veterans of Foreign Wars Memorial Highway
