An electronic recording of the meeting was made and filed with supporting documents in the Transportation Commission office.

### **Audience Participation**

Vice Chair Aden mentioned that there were no members of the audience who had signed up to speak to the Commission.

### **Individual Commissioner Comments**

Commissioner Gilliland reported that she had joined Don Hunt, Ben Stein and Mickey Ferrell for a trip to Washington, D.C for a congressional visit. She mentioned that they had met with 5 State Representatives and that the trip was very productive.

Commissioner Connell stated that she had recently given the Transportation Matters presentation to 114 people in the Steamboat area and that it was very well received.

Commissioner Parker related details of a recent trip to Salt Lake City, Utah and praised the state for its priority for transportation. He confirmed that Don Hunt, Executive Director had done a good job of answering questions at a recent meeting of the Colorado Forum where transportation was the focus.

Commissioner Aden spoke of a recent trip abroad and told of the Sydney Harbour Bridge in Australia and the transportation innovations in place on the bridge. He additionally noted that while in Bali he saw road construction workers who weren't wearing safety gear or appropriate protective clothing and it brought to mind how fortunate those who work on construction jobs in the US and the best safety practices that are used.

WHEREAS, Parcel 8A shown in Exhibit A (the Property), was acquired in November 1948 by CDOT for Project F004-1(6) and

WHEREAS, the Department of Transportation, Region 4 has determined the Property is excess land no longer needed for transportation purposes; and

WHEREAS, Title 23, Part 710, Section 403(d)(1) of the Code of Federal Regulations, allows CDOT to convey property to other governmental agencies when the Property will be used for a nonproprietary public use; and

WHEREAS, upon the Transportation Commission concurrence that the Property is longer needed for transportation purposes, Region 4 will convey the Property to the City of Fort Collins; and

WHEREAS; if the Property ever ceases to be used as a nonproprietary public use, the Property will revert back to CDOT ownership; and

WHEREAS, the conveyance of the Property will alleviate CDOT of future maintenance expenditures and liability associated with the Property; and

WHEREAS, the Department of Transportation, Region 4 has declared through Timothy Harris as Chief Engineer, that the Property is no longer needed for transportation purposes; and

WHEREAS, the Chief Engineer and the Department of Transportation are authorized pursuant to C.R.S. 43-1-106(8)(n), 43-1-110, 43-1-114(3), and 43-1-210(5) to make determinations regarding property to be declared excess and not needed for transportation purposes; and

WHEREAS, the Transportation Commission concurs with the Chief Engineer that the Property is no longer needed for transportation purposes; and

WHEREAS, the Colorado Department of Transportation acquired 1-EX in 1933 for SH 34 right of way; and

WHEREAS, Parcel 1-EX is a 1,416 square foot parcel in the NE ¼ SE ¼ of Section 5, Township 4 North, Range 71 West of the Sixth Principal Meridian, Larimer County, Colorado; and

WHEREAS, Parcel 1-EX is an approximately 10 foot wide strip of land that that is well outside the traveled way and approximately 12 feet above the road grade; and

WHEREAS, the corner of the house on the property adjacent to Parcel 1-EX, which was built in 1954, encroaches on the edge of Parcel 1-EX; and

WHEREAS, CDOT Region 4 has made the determination that Parcel 1-EX is no longer needed for transportation purposes; and

WHEREAS, CDOT Region 4 desires to sell Parcel 1-EX to the adjacent property owner for fair market value in accordance with Colorado Revised Statute 43-1-210 (5) ; and

WHEREAS, the sale of Parcel 1-EX will not affect the design, construction or utility of SH 34; and

WHEREAS, the Department of Transportation, Region 4, recommends that the property described as 31-EX of Project FAP 9-R-6 be declared excess property; and

WHEREAS, the Chief Engineer and the Department of Transportation are authorized pursuant to C.R.S. 43-1-106(8)(n), 43-1-110, 43-1-114(3), and 43-1-210(5) to make determinations regarding property to be declared excess and not needed for transportation purposes; and

WHEREAS, the Departments Region 6 Office has also agreed to convey Parcels 9X and 16X of the above referenced Project for nominal value upon commission approval; and

WHEREAS, if the Property ever ceases to be used as a nonproprietary public use, the Property will revert back to CDOT ownership; and

WHEREAS, the Departments Region 6 Office has also agreed to convey Parcels 9X and 16X of the above referenced Project for nominal value upon commission approval;

NOW THEREFORE BE IT RESOLVED, that the Department of Transportation be given authority to dispose of Parcel 17X and convey Parcel 9X and 16X of Project STU M040-011 as shown on Exhibit A, and contained in the official agenda, to the City of Arvada. Parcel 17X will be sold for fair market value. Parcels 9X and 16X will be conveyed for a nominal fee.

WHEREAS, the Department, in response to an audit by the Department of Personnel/State Controller in 2008-2009 commenced a revision of its practices and procedures; and

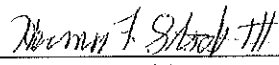
WHEREAS, the Office of Procurement and Contract Services has focused its methods of improvement on the findings of a 2012 internal audit; and

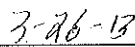

WHEREAS, CDOT has awarded more than \$13 million in SAFETEA-LU SRTS funds since 2005; and

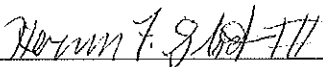

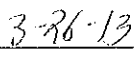
