The Request for Proposals (RFPs) evaluation process has been completed for the Construction Manager (CM) Services for the Preconstruction Phase of the CO119 Safety & Mobility Improvements & Bikeway Project (the Project). The evaluation process conforms to all applicable State and Federal requirements and is in accordance with the approved Project CM RFP Evaluation Manual. On June 28th, 2023, the Executive Oversight Committee (EOC) for the evaluation process approved the Final Recommendation for the Shortlisted Proposers to advance to the Interview Phase.
