Request for Letters of Interest for Construction Manager / General Contractor Services CO 119 Safety & Mobility Improvements & Bikeway Project

The Colorado Department of Transportation (CDOT) is soliciting Letters of Interest (LOI) from companies or teams interested in providing Construction Manager/General Contractor (CM/GC) services for the CO 119 Safety & Mobility Improvements & Bikeway Project.

The Project is located in Boulder County from Foothills Pkwy to Hover Street along the CO 119 Corridor. The purpose of this project is to provide critical intersection improvements, commuter bikeway, and implement Bus Rapid Transit (BRT), connecting the Cities of Boulder and Longmont. Traffic signals will be upgraded to provide transit signal priority where needed through the corridor to reduce transit travel time. This is a joint project between CDOT, RTD & Boulder County with CDOT leading the CM/GC construction. The RFP describes the scope and funding associated with each Agency.

The estimated total program cost of the Project is between \$150M - \$160M. The project has secured approximately \$130M to date. Additional funding is being pursued through DRCOG and a USDOT RAISE grant so there are several other scope items that are not currently included in this total.

CDOT has determined that the delivery method that can best be leveraged to maximize the benefit of this project is CM/GC. This method affords CDOT the opportunity to gain a contractor's input while partnering with a consultant design firm in the development of the project.

The non-prioritized, goals for this project include the following:

- 1. Improve safety in the whole corridor
- 2. Maximize intersection operational efficiency
- 3. Maximize corridor-wide operational efficiency
- 4. Maximize the number of people able to move through the corridor
- 5. Improve transit travel times
- 6. Improve connectivity to the bicycle and pedestrian network
- 7. Build the full scope of the project at the current construction cost estimate.
- 8. Retire, mitigate, or assign 100% of the Project risks for each CAP

The Project goals will continue to be refined along with the development of the RFP and may be altered, reduced, or added to prior to issuance of the Final RFP.
