Request for Letters of Interest for Construction Manager (CM) Services

Vasquez Blvd - I-270 to 64th Avenue

The Colorado Department of Transportation (CDOT) is soliciting Letters of Interest from companies or teams interested in providing Construction Manager/General Contractor (CM/GC) services for the Vasquez Blvd. - I-270 to 64th Ave. project. The project includes significant modifications to the Vasquez Blvd and 60th Avenue intersection, the construction of a signalized T-intersection located at Vasquez Blvd. and 62nd Ave, and the construction of new local access roads West of the Vasquez Blvd. and 60th Ave. intersection. The construction budget for this project is estimated to be in the range of \$13-15 Million.

CDOT has determined that the delivery method that can best be leveraged to maximize the benefit of this project is CM/GC. This delivery method affords CDOT the opportunity to gain a contractor's input while partnering with a consultant design firm in the development of the project.

The non-prioritized goals for this project include the following.

- Improve the reliability of traffic and pedestrian movements through the Vasquez Blvd/60th Ave intersection.
- Balance access between the transportation network and adjacent land uses.
- Effectively connect current and future modes and networks, including roads, bicycles, pedestrians and transit.
- Improve the ability of freight to efficiently travel through and within the area.
- Minimize and mitigate impacts to the built environment consistent with local master plans.
- Avoid and minimize impacts to the natural environment.

The Project goals will continue to be refined along with the development of the RFP and may be altered, reduced or added prior to issuance of the RFP.
