These surveys may include the exterior inspection of structures and buildings; the collection of chipped stone, biological, botanical, or fossil specimens; or sampling of subsurface soil material. <input type="checkbox"/> Perform real estate appraisal, or other physical inspections necessary to review the property, including any structures for possible acquisition. <input checked="" type="checkbox"/> Conduct soils or hydraulics investigation, including sampling and subsurface investigation, to determine drainage characteristics, soil types or other geologic conditions or activity. <input type="checkbox"/> The use of hand tools, drill rig, supply truck, and other assigned vehicles are usually involved in the subsurface investigation. CDOT and its authorized representatives may penetrate the land surface with equipment and temporary installation of monitoring devices.
