Procedural Objective

This document is intended to assist the Region Civil Rights Office with updating the payments for non-Commercially Useful Function (CUF) activities with regard to counting toward the contract Disadvantaged Business Enterprise (DBE) goal in B2GNow.

System Procedures

1. Log into the B2GNow system at http://cdot.dbesystem.com.



2. Locate the desired contract by using the search menu of the left-hand side of the screen or the priority flagged contract in the dashboard.

- 3. Follow steps 4-7 of this process guide if a portion of the contract is to be counted as eligible participation and a portion of the contract is **not** to be counted as eligible participation due to the outcome of a commercially useful function review.
- 4. From the "Contract Management" page, click the "Subs" tab. Locate the subcontractor to be edited and click "Edit" under "Actions."

- 8. Follow steps 9-16 of this process guide if the DBE is NOT considered to have eligible participation as a result of a commercially useful function or if a commercially useful function (CDOT Form 1432) was not received by the Prime Contractor for a DBE. In this scenario, zero dollars of the DBE payments shall count toward the DBE contract goal.
- 9. From the "Contract Management" page, click the "Subs" tab. Locate the subcontractor to be edited and click "Edit" under "Actions."

- 13. If payments to the DBE have been reported in B2GNow to count toward the contract goal, however it was later determined that a DBE did not perform a CUF or a CDOT Form 1432 was never received by the Prime Contractor, the payments shall be updated in B2GNow to reflect this information. The following steps will change the payments that have been reported from counting as eligible participation to not counting toward the DBE contract goal.

15. Under the appropriate firm name, select the "Payments" button.
