## **Procedure Objective**

This document is intended to assist the Region Civil Rights Office with uploading the approved or denied CDOT Form 1420, DBE Participation Plan Modification Request, CDOT Form 1415, Commitment Confirmation, and any supporting documentation in B2GNow. This document is also intended to assist the RCRO with updating DBE commitment information in B2GNow.

## **System Procedures**

1. Log into the B2GNow system at <a href="http://cdot.dbesystem.com">http://cdot.dbesystem.com</a>.



2. Locate the desired contract by using the search menu of the left-hand side of the screen or the priority flagged contract in the dashboard.
