### **Procedural Objective**

This document is intended to assist bidders with properly submitting the CDOT Form 1414, Anticipated DBE Participation Plan, which documents the DBE commitments made by the bidder on a contract.

### **System Procedures**

3. Enter DBE commitment information by entering the DBE firm name, the work to be performed by the DBE on the contract, and the commitment amount (in \$) to the DBE. The "Commitment Amount" does not have to equal the total amount of the subcontract with the DBE. The "Commitment Amount" should only reflect the dollar amount the bidder is willing to commit to the DBE.

**Note 1:** Eligible participation is the work by a DBE which counts as valid DBE participation on the contract and may be used towards the fulfillment of a commitment. The DBE must be certified by the Colorado UCP in the work to be performed. DBEs are certified in particular areas of work which are designated by a work code. Each DBE's work codes can be found on their profile on the Colorado UCP DBE Directory.

**Note 2**: The "Commitment Amount" should be identical to the "Eligible Participation" amount unless the DBE is subject to special DBE counting rules for suppliers under 49 CFR 26.55(e), whereby regular dealers may only count 60% of the cost of materials and supplies as "Eligible Participation," brokers may only count the total amount of its commission and fees as "Eligible Participation," or distributors may only count 40% of the cost of materials or supplies (including transportation costs) by a DBE.

**Note 3:** If there is a 0% DBE goal on a contract, the bidder is not required to complete the CDOT Form 1414. If a CDOT Form 1414 is completed on a contract with a 0% DBE goal, the bidder is making a voluntary DBE commitment and DBE utilization plan will be created. Prior to the utilization plan being created in this situation, CDOT will verify with the bidder that a voluntary DBE commitment is intended.

4. The bidder shall enter the total dollar amount of the bid in "Total Bid Amount." The CDOT Form 1414 will automatically calculate the "Total Eligible Participation" by DBEs and the "Total Eligible Participation Percentage" by DBEs on the contract.
