**US 50 Las Animas to Lamar – Design Projects & US 50 East of Pueblo Safety project**

**Public Notice for Professional Consultants**

The Colorado Department of Transportation (CDOT) intends to hire one (1) Professional Consultant for this Project. The selected Consultant will contract to provide project specific consultant services to include those specific services set forth below.

DESCRIPTION: Consultant services will consist of all services necessary to perform general engineering for highway plan design including the following services:

**US 50 East of Pueblo Safety Projects:**

- Drainage Analysis and Improvements along the corridor.
  - LaJunta drainage analysis (West of Town) and plan preparation for improvements
  - Drainage support for projects done by CDOT
- Design or design support for improvements extending passing lanes at on US 50 at the Apishpa Bridges (EB Structure L-21-G and WB Structure L-21-DA)

**US 50 Las Animas to Lamar Design Projects**

- Passing Lanes between Las Animas and Lamar
  - CDOT Survey being conducted from MP 410-421
  - Possible passing lanes West of Hasty within CDOT ROW
  - Possible passing lanes East of Hasty (would require ROW acquisition)
- Add turning lane and acceleration lane at Hasty on US 50
- Improvements at SH 196 and US 50
  - Improve sight distance and accel/decel lanes
  - Provide passing lanes east and west of the junction of US 50 and SH 196
  - May involve ROW Acquisition.
- Miscellaneous projects

This Project-specific contract work will be done on an “as needed basis.” The term, “as needed,” means that neither CDOT nor the Consultant has an obligation under the contract unless and until a task order is issued. A contract resulting from the Invitation for Consultant Services is considered a “pricing agreement.” CDOT anticipates that the compensation format on this contract will be “specific rate of pay,” subject to further review by CDOT.

NOTE: For all agreements that include final design services (either Non-Project Specific Construction Engineering agreements or Project Specific agreements) consultants, and their sub consultants having more than a 20% share in the final design portion of the contract, shall not be able to compete for construction engineering services on the same job for which they are providing final design services. Consultants who perform preliminary design and environmental review services may continue with, or compete for, final design services.

**SPECIAL PROJECT REQUIREMENT:** All work is to be performed under the direction and supervision, appropriate to the task, of a Colorado-Licensed Professional Engineer, a Colorado-Licensed Professional Land Surveyor for Surveying services, a Colorado-Licensed Landscape Architect, a Certified Industrial Hygienist, or, as appropriate, any combination of the foregoing.

### **Interested Consultants:**

The prime firm of each team must be on CDOT's list of prequalified consultants by **July 23, 2009**. Prequalification must be done annually. Consultants who are not prequalified or who have questions regarding their prequalification should immediately contact Michael Dapceвич, Agreements Office at telephone (303) 757-9618.

**For the Capacity factor included in the Statement of Interest portion of the consultant's submittal, and described in the SOI/WP Preparation Instructions For Consultants, the prime firm must show, for the prime firm or any member of its team, capacity in the following disciplines: BR – Bridge Design; CE – Civil Engineering; EN – Environmental Engineering; GL – Geological Engineering; GE – Geotechnical Engineering; HD – Highway and Street Design; HY – Hydraulics; LA – Landscape Architecture; MT – Materials Testing; SO – Soils Engineering; TR – Traffic Engineering.**
