The Colorado Department of Transportation (CDOT) Region 3 intends to hire one (1) Professional Consultant for this Project. The selected Consultant will contract with CDOT to provide Project Specific Construction Management Inspection & Materials Testing Engineering Services for the I-70 Colorado River South Project to include those specific services set forth below and in the Scope of Work (SOW)

CDOT intends to hire One (1) consultant firm for this project.

Description of Project:

This Project is a reconstruction with large animal crossing structures and game fence on State Highway 9 located in Grand County. The project length is approximately ten (10) miles and the work consists of: Earthwork, Aggregate Base Course, Three-Sided Pre-Cast Structures (under and over SH 9) with detours, Game Fence with access treatments, Drainage Structures, Access Roads, Hot Mix Asphalt, Epoxy Pavement Marking and Traffic Control.

An anticipated project starting date is **October 1, 2014**. The expected duration of the project is approximately three (3) years.

Labor Force Summary:

Under this agreement the Consultant will provide a team of personnel to perform Construction Management / Construction Inspection & Materials Testing Services, to assist the CDOT Project Engineer and CDOT Head Tester on the project. A list of personnel and qualifications will be submitted as part of the proposal. Previous CDOT CM experience is desired. The following labor needs are anticipated:

1. One Project Engineer will be utilized throughout active project construction and project finalization to act as an Office Engineer and cover the project when the CDOT Project Engineer is not present.
2. One Assistant Project Engineer -will be utilized throughout active project construction and Project finalization.
3. One Project Tester-will be utilized throughout active project construction.
4. FOUR Construction Inspectors (Erosion Control and Traffic Control Inspector focus for two of the four) will be utilized throughout active project construction.

CDOT anticipates that the compensation format on this contract will be "Specific Rate of Pay". Execution of the contract will be subject to the bid award for the above-mentioned construction project.

NOTE: For this Project Specific Construction Management agreement, any consultants or sub consultants having more than a 20% share in the final design portion of this project shall **not** be able to compete for the construction management services contained in this advertisement.

SPECIAL PROJECT REQUIREMENT: All work is to be performed under the direction and supervision, appropriate to the task, of a Colorado-Licensed Professional Engineer, a Colorado-Licensed Professional Land Surveyor for Surveying services, a Colorado-Licensed Landscape Architect, a Certified Industrial Hygienist, or, as appropriate, any combination of the foregoing.

The prime firm of each team must be on CDOT's list of prequalified consultants by July 31, 2014. Prequalification must be done annually. Project Team; Firm Capability; Past Performance on Similar Projects/Similar Teams; Work Location; Capacity; UDBE Participation; ESB Participation; Project Goals, Project Control, Project Concept, Project Critical Issues, and Workload Factor.

NOTE: Firms submitting a Statement of Interest/Work Plan (SOI/WP) must, in their submitted SOI/WP, expressly commit, and identify by name, key employees of their own staff, as well as of the staffs of the sub-consultants on their teams, to be available to do the Work.
