CDOT HQ Staff Bridge desires to advertise the selection with an “Optional” Interview phase.

CDOT HQ reserves the option to award one agreement based solely on the information submitted from consulting firms SOI and Work Plan. Should there not be a clearly superior proposal submitted, and the scoring and ranking does not provide a unanimously decided superior SOI and Work Plan, CDOT HQ would short list the 3 most qualified firms for an Interview phase.

NOTE: Firms submitting a Statement of Interest/Work Plan (SOI/WP) must, in their submitted SOI/WP, expressly commit, and identify by name, key employees of their own staff, as well as of the staffs of the sub-consultants on their teams, to be available to do the Work.

CDOT requires **seven (7)** copies of your Statement of Interest (SOI)/Work Plan (WP) submittal to accommodate the members of the board. Please refer to the SOI/WP instructions to ensure compliance with the page and exhibit limits for the SOI/WP sections of your submittal. Submit all copies of Statement of Interest/Work Plan by the due date and time as stated in the "Invitation for Consultant Services."

The prime firm or one of its sub-consultants must be prequalified in the following disciplines:

**BI-Bridge Inspection; CE – Civil Engineering; GE – Geotechnical Engineering;  
HD – Highway and Street Design; TR – Traffic Engineering; SE Structural Engineering  
UT - Utilities**

By submitting an SOI/WP on this project the consultant is deemed to agree to the process described herein.

You must be on CDOT's list of pre-qualified consultants by November 6<sup>th</sup> 2014 to be considered on this project.

**SOI Due Date is Thursday November 13<sup>th</sup> 2014 12:00 Noon**

CDOT will notify you of the result of the selection by telephone and electronic mail.
