“Optional Interview”

The Colorado Department of Transportation (CDOT) intends to hire one (1) Professional Consultant for this Project. The selected Consultant will contract to provide project specific consultant services to include those specific services set forth below.

Description

In 2011 the Federal Highway Administration (FHWA) and Colorado Department of Transportation (CDOT) completed a Tier 1 Record of Decision document for the I-70 Mountain Corridor. The Tier 1 decision selected the Preferred Alternative, a long-term 2050 vision of a multimodal transportation solution for the Corridor that includes non-infrastructure components, an Advanced Guideway System, and highway improvements. Subsequent Tier 2 NEPA processes will be completed to develop and evaluate specific projects consistent with the Tier 1 decision.

Tier 2 processes are needed to identify specific alternatives and alignments consistent with the Tier 1 decision. This project will focus on completion of the decision document for the West Vail Pass Environmental Assessment (EA) to study safety improvements on the west side of Vail Pass, where the highway's steep grades can result in conflicts between vehicles traveling at substantially different speeds. CDOT believes that the West Vail Pass project as identified from MP 180 to 190 constitutes an independent component of the overall I-70 Mountain Corridor. As such, we believe the West Vail Pass project can be planned as a separate action from all other reasonably foreseeable transportation projects in the area. The Environmental Assessment (EA) for safety improvements on the west side of Vail Pass was started in 2006 but was stopped until the Tier 1 Record of Decision was completed. This project will utilize the information that was gathered to complete the EA.

Project Location:

This project is located on I-70 between milepost 180 and milepost 190.11 in Eagle County.

The overall purpose of the project is to improve safety on West Vail Pass including decreasing the number of accidents, reducing erratic driving behavior due to speed differentials, and reducing speed differentials. Detailed goals will be defined by the Project Leadership Team. Preliminarily, this project is intended to produce the following improvements:

- A. Environmental – minimize environmental effects
- B. Follow context sensitive guidelines and principles
- C. Improve Safety and Quality of Multi-Use Trail
- D. Implement Black Gore Creek SCAP

This Project-specific contract work will be done on an “as needed” basis. The term "as needed" means neither CDOT nor the consultant has an obligation under the contract unless and until a task order is issued. Contracts resulting from the Invitation for Consultant Services are considered a "pricing agreement". CDOT anticipates that the compensation format on this contract will be “cost plus fixed fee,” subject to further review by CDOT. Execution of the contract will be subject to the bid award for the above-mentioned construction project.

Special Project Requirement: All work is to be performed under the direction and supervision, appropriate to the task, of a Colorado-Licensed Professional Engineer, a Colorado-Licensed Professional Land Surveyor for Surveying services, a Colorado-Licensed Landscape Architect, a Certified Industrial Hygienist, or, as appropriate, any combination of the foregoing.

Interested Consultants:

The prime firm of each team must be on CDOT's list of prequalified consultants by **December 15, 2016**. Prequalification must be done annually. Should Interviews be required, from those firms submitting a Statement of Interest/Work Plan (SOI/WP), CDOT will short-list up to 3 (three) firms for interviews. CDOT may make the Final Selection at either meeting, with alternate firms 2 and 3 listed and submitted to CDOT Chief Engineer for final approval.

NOTE: Firms submitting a Statement of Interest/Work Plan (SOI/WP) must, in their submitted SOI/WP, expressly commit, and identify by name, key employees of their own staff, as well as of the staffs of the sub-consultants on their teams, to be available to do the Work.

DBE GOAL: The DBE goal for this project is: **10% (Ten Percent)**

The Department has determined the contract goal for DBE participation in this contract (if any) will be met with certified DBEs and ESBs who have been determined to be underutilized on professional services contracts. To be eligible for contract award, the prime consultant must have an Audited Indirect Cost Rate that is compliant with Federal Acquisition Requirements. (FAR Compliant)
