Please refer to the SOI/WP Instructions to ensure compliance with the page and exhibit limits for the SOI/WP sections of your submittal. Submit all copies of Statement of Interest/Work Plan by the due date and time as stated in the "Invitation for Consultant Services."

**SPECIAL PROJECT REQUIREMENT:** All work is to be performed under the direction and supervision, appropriate to the task, of a Colorado-Licensed Professional Engineer.

PLEASE NOTE:

ALL PARTIES SUBMITTING A PROPOSAL, IN ADDITION TO ALL SUBCONSULTANTS ON THE PROPOSED TEAM, MUST BE PREQUALIFIED AND HAVE A MPA WITH CDOT PRIOR TO AWARD OF CONTRACT.

Prequalification must be done annually. **The prime firm or a member of its team must be prequalified in the following disciplines: Civil Engineering (CE), Management – Construction (MC) and Materials Testing (MT).**
