

Flagging Information

Proctors

As of April 1, 1995, the Colorado Department of Transportation (CDOT) will no longer provide proctors to certify flaggers for CDOT construction projects. Beginning April 1, 1995, the Contractors who employ flaggers will be required to certify their own employees.

CDOT's Standard Specifications Sections 630.12, 3rd paragraph, (a) require all flagging personnel to have completed the minimum training requirements within two years of starting work on the project. CDOT training requirements are outlined in CDOT Procedural Directive 306.1. These requirements include reviewing the latest edition of the "Flaggers Training Manual," viewing the video entitled, "The Flagger" and obtaining a passing score of at least 80% on an exam administered by an approved proctor.

Contractors should designate their own proctor(s) to certify their own employees who intend to flag on CDOT construction projects.

CDOT will provide Contractors with Procedural Directive 306.1, flagging manuals, a copy of the video, exams and flagging certification cards.
