1. Describe your major areas of work experience/expertise:

Work with BOR was in their construction program on heavy civil projects. Work was primarily embankment and concrete dams; canals and piplines; power and pumping plants. As adjuncts to these projects were the construction of highways and bridges for relocations, modifications, crossings etc. These projects dealt with state highway departments and counties in Calif, Okla, Nev, Wyo and Oregon

In one case the court settled in favor of the Government, in the other, it was settled by negotiations after depositions. 3. Describe your knowledge of construction contract law:

While I have no formal training in construction law, my experience has given me a feel and appreciation for contract law gained through the "school of hard knocks".

4. Describe your experience with construction contract administration:

The construction offices I headed provided the full range of contact administration on a day to day basis as part of the construction management services my offices provided. The formal contracting officer, however, was not part of my staff and located in another office, thus providing the necessary checks and balances in the contracting process.

5. Describe your construction field experience:

Almost all of my experience was at the field construction office level, all in the heavy civil arena. I did have two years in the design of heavy civil works including the design of the State Highway 49 and 152 relocations in California.

6. Describe your DRB (or arbitration) training, certification, and experience:

My training was through the Disputes Resolution Board Foundation. I have been on a list of qualified DRB candidates for IDOT and UDOT and have served as an owner's representative on DRB's, primarily for the Southern Nevada Water Authority.

7. Describe your employment/retirement status and availability to serve on a DRB and geographical area:

I retired from Federal service in 2001 and have been involved in short term consulting assignements, primarily associated with construction or construction management matters and DRB assignments. I am therefore available to serve on DRB's and am willing to travel to any location.
