### Precast Structure Manufacturers Certification Letter

January 2, 2021

Manufacturers,

This letter is a notification to all Precast Structure Suppliers as defined in CP 11 (Precast Structure) of the CDOT Field Materials Manual (FMM) that will be supplying Precast Structure product for CDOT projects for the calendar year 2021. Failure to comply with the protocol as described may delay or prevent your specific facility from being posted to the CDOT Qualified Manufacturers List (QML) and therefore delaying your Precast Facility products from being used on CDOT projects.

Please review the 2020 CDOT FMM requirements [CP 11 (Precast Structure)].

February 1st of each year is considered the end of the previous construction season and the beginning of a new season. All Precast Structure Manufacturers approved will remain on the CDOT QML until suspension or removal by CDOT Engineer. The referenced Manufacturers will remain posted only as an aid to the Manufacturer and CDOT Project Personnel as to what Manufacturers are available for use on CDOT projects.

1) Manufacturers must submit an updated Quality Systems Manual [CP11 (Precast Structure Section, 9.1)] both a complete printed and bound original (3-ring binder) and one complete electronic copy (Adobe Acrobat PDF format) dated February 1, 2020 or newer and sent to the following address;

2) Manufacturers must submit a completed CDOT Precast Manufacturers QSM checklist for each Precast Structure facility expected to be placed on the CDOT Qualified Manufacturers List [CP 11 (Precast Structure) Section 9.1]. Your approved and accepted Precast Structure facilities can be viewed on the CDOT Qualified Materials List (QML) from the CDOT link listed below.

2a) The Posted CDOT Precast Manufacturers QSM Checklist should be used as examples of what is correct in format and content. They should be adhered to unless there is an error. Errors are to be communicated immediately to the CDOT Product Evaluation Coordinator. It must be indicated within the Description of the Precast Facility.
