





## Comments:

This Colorado Construction Cost Index is composed of six indicator items and based on bid prices relative to the unit prices of 1987 (unit index=100). The Index varies due to type and location of projects in addition to overall economic conditions.

## Earthwork (Excavation and Embankment):

The average price was \$5.80 a cu. yd. which is down \$6.32 from the previous quarter. This reflects more competition with lower profit margins for earthwork projects.

## Hot Mix Asphalt:

The average price was \$100.36 a ton which is up \$3.73 from the previous quarter. In the fourth quarter asphalt cement shortages continued to cause higher HMA prices. In addition, the majority of asphalt overlay projects bid in the fourth quarter were in remote areas.

## Concrete Pavement:

The average price was \$31.60 a sq. yd. which is down \$21.71 from the previous quarter. Concrete pavement quantities were over five times as large as the third quarter. In addition, cement demand is down, steel prices are lower and competition has increased.

## Structural Steel:

No project with a structural steel item was awarded in the fourth quarter.

## Structural Concrete:

The average price was \$430.70 a cu. yd. which is down \$401.40 from the previous quarter. An increase in bidding competition and a decrease in fuel prices contributed to the decrease.

## Reinforcing Steel:

The average price was \$1.11 a lb which is down \$0.37 from the previous quarter. Steel prices have decreased over this quarter. In addition, increased competition and lower profit margins contributed to the decrease.

## ADDITIONAL INFORMATION:

For the 4<sup>th</sup> quarter, the category indices showing a decrease were Earthwork, Concrete Pavement, Structural Concrete, and Reinforcing Steel. The only category index showing an increase was Hot Mix Asphalt.

22 projects were bid and awarded this quarter for a total of \$40,302,631.70. By comparison, 36 projects were bid last quarter. The six categories for CCI items totaled \$15,323,605.95, which is 38.0% of the total awarded amount. 8 maintenance contract projects were bid this quarter. No metric, Lump Sum or Design Build projects were bid this quarter.

The competition for projects increased to 5.45 bidders from 4.97 bidders for each project on average from last quarter.
