WHAT'S DRIVING THE INCREASE?

**THE AVERAGE IMPAIRED DRIVER IN
COLORADO NOW QUALIFIES AS
A PERSISTENT DRUNK DRIVER:**

0.164 Statewide Average BAC (blood alcohol content) in DUI Cases (FY16)
— more than twice the legal limit of .08

0.15* BAC Threshold to be considered a Persistent Drunk Driver (PDD)
— even if it's your first DUI.

55% Amount of cost increase due to average DUI now being PDD.

**Drivers who refuse chemical testing or have two or more impaired driving offenses are also considered PDD*
