Enclosed is the Eleventh Supplement to the FY 2012 Budget.

### REGION 1

- \$3,580,900 Construction - US 85 Cook Ranch to Louviers over draws in Douglas County. New structures G-16-E and G-16-F replacing existing structures G-16-B (structure rated at 49.0/functionally obsolete) and G-16-C (structure rated at 23.3/structurally deficient). Establish budget for the construction phase of this project in order to replace the existing bridges. Note: This project is associated with project 15024 also being reviewed by the Transportation Commission. This project will address two of the three worst structures in Region 1 and removes the 10<sup>th</sup> worst bridge in the State. Construction advertisement for both projects is scheduled for May 2012. (18899/10001....)
