Response from Director Adams

Date: November 2023

Mrs. Hutton and I talked about her concerns regarding the C-470 Express Lanes. She indicated she is a former CDOT Chief Engineer and was calling on her, her husband and a number of her acquaintances (most of whom reside in south Douglas County). Their concerns have to do with the recently implemented fines for inappropriate entry into the Express Lanes (entering into the Express Lanes over the solid lines). Mrs. Hutton and her acquaintances feel the fines are unfair. They believe drivers should be able to use their judgement and cross the solid lines in circumstances where they perceive traffic slowdowns or accidents. They do not perceive the safety issue in the same way nor do they feel a "strict" policy regarding imposing the fines is warranted.

In her words "as long as the driver has exercised due caution and there is a slowdown or accident and the driver pays the Express Toll fee they shouldn't be charged a fine". I gather the only time they believe it would be appropriate to charge fines is when the driver fails to pay the toll.

She told me that Karen has indicated that we will be discussing this at the December meeting. I'm not sure what discussion would take place other than an update from Kelly similar to what we received last week.I think it's too early to do anything other than continue reviewing the data (so far it seems like behavior is changing). So in the first couple of months the fines are driving the change in behavior.

I did invite Mrs. Hutton asked her acquaintances to reach out and share their views as well.

In the meantime I think we should continue gathering the data and listening to our constituents.

We paid it to protect our credit but we didn't know that prevented us from addressing it and challenging it. By paying, we believed that took away the fear of reprisal. The person on the phone was so cruel we just paid it to give us time to defend why we couldn't have possibly covered this before the double date.

It's a sick policy and it means placing people in strange situations like us being forced to give you money we don't have. Why can't we pay the original violation fee? That's only right and fair.

How do we contest this?

I'm happy to come to the next board meeting so you can hopefully develop a more thoughtful policy that includes bereavement.

We have evidence we were in Florida for those dates, making it impossible to respond to this notice.

Thank you for reaching out with your feedback.

I'm sorry that this issue came up at a difficult time while you were out of town caring for a sick friend.

The point you raise about extenuating circumstances is a good one. Unfortunately, the reasons to dismiss a citation the customer service representatives have available to them are limited because of some procedural issues with the state controller.

However, given your feedback and that of other members of the public, we will be holding a policy discussion with the CTIO Board on the Safety Enforcement Program soon (date TBD) to discuss if/how the policy can be updated to allow more flexibility for CSRs to take into account situations like the one you mentioned.

Your feedback and this response will be included in the board materials shared with the CTIO board before the next meeting on January 17th.

Express Lanes Safety Enforcement Program Ingress and Egress

CTIO staff have also received feedback regarding Express Lanes's ingress and egress points. CTIO is currently reviewing these Ingress and Egress points with CDOT traffic engineers to identify where modifications can be implemented safely.
