

Floyd Hill Express Lanes Project: Overview

- The Project's scope includes:
 - Add ~5 miles Express Lane in the westbound direction
 - Provide westbound and eastbound I-70 with curve flattening and safety improvements
 - Redevelop frontage roads for emergency and detour access
 - Develop a mobility hub with EV infrastructure and accessibility options
 - Greenway improvements, including those addressing Americans with Disabilities Act (ADA) items
 - Construction of a climbing lane on eastbound I-70 at Floyd Hill for heavy commercial or slow-moving vehicles
 - Implementation of environmental mitigation to enhance wildlife connectivity, air/water quality, and stream conditions
- To design and construct the project, Kraemer North America was selected in 2023 by CDOT as the Project's Construction Manager/General Contractor (CM/GC)

Project Map and Corridor Express Lanes






Floyd Hill Express Lanes Project: Traffic & Revenue (T&R)

- While the Project is located along I-70 in Clear Creek County, most of the peak traffic is external to this county
- The Corridor benefits from strong T&R performance due to typical interstate travel demand, diverse users (including significant recreational demand on weekends/holidays), and continued strong regional growth trends

Congestion Snapshot: WB Saturday Speeds along Project Area




- During winter and summer seasons, travelers experience substantial traffic delays on weekends and holidays and, to some extent, work trip delays during the week
- The existing and projected travel demand for this Corridor exceed the design capacity of the existing facility, resulting in severe
 congestion for extended periods of time which will continue to worsen without the Project improvements due to the expected
 population and employment growth, ultimately resulting in even greater weekend/holiday congestion and more frequent weekday
 delays

Key Project design and construction timelines and major milestones include:






Anticipated Project Outcomes

The implementation of the Project will improve mobility and safety in the Corridor by:

- ✓ Increasing Corridor throughput volume by 53% from 3,600 to 5,500 vehicles per hour (VPH) to better manage peak congestion
- ✓ Improving travel time reliability for the diverse set of Corridor users (e.g., tourism/recreational, goods movement, etc.) to enhance transit service
- ✓ Improving safety along the Corridor and improving emergency access
- ✓ Providing additional capacity to support future growth and Corridor demand


Floyd Hill Project Funding & Financing

- Transportation
 Infrastructure Finance and Innovation Act (TIFIA) eligible costs are estimated to be \$737 million (i.e., preconstruction costs, construction costs, and reserve account funding)
- It is estimated that the Project can support up to \$243 million in TIFIA gross proceeds

Source	Description
CDOT Strategic Funding	Provided by CDOT through its capital budget and via the traditional appropriations process to allocate funding for transportation needs
Bridge and Tunnel Enterprise (BTE) Funding	Provided by BTE, capitalized using a bridge and tunnel safety surcharge imposed on vehicle registration based upon vehicle weight, and allocated by CDOT
INFRA Grant Award Funding	Funds from the USDOT INFRA Grant program to deliver the Project and support final design and construction activities
TIFIA Financing Proceeds	Financing proceeds backed by toll revenues from the I-70 Mountain Corridor Express Lanes network
