Subject: Approval of Time-of-Day Toll Rates and Dynamic Pricing Algorithm Criterion Adjustments for Express Lanes

Purpose:

This memorandum presents a request from the Colorado Transportation Investment Office (CTIO) Staff that the CTIO Board of Directors approve the proposed toll rate adjustments for Central 70, I-25 South Gap, I-25 US 36 to 120th Ave (Segment 2), I-25 120th Ave to E-470/Northwest Parkway (Segment 3), and C-470 (I-25 to Wadsworth Blvd) Express Lanes. This request includes both Automated Vehicle Identification (AVI) and License Plate Tolling (LPT) adjustments that were presented at the May 2025 Board Meeting.

Requested Action:

Approve Resolution #472, adopting the fiscal year (FY) 2025-26 time-of-day toll rates and dynamic pricing criterion adjustments. The complete technical memo and supporting analysis for these recommendations can be found in the <u>May 2025 Board documents</u>.

Recommended Adjustments to Toll Rates for I-25 Segment 2 (US 36 to 120th Ave) Express Lanes:

Based on the results of the toll rate adjustment analysis, which was presented in May 2025, staff recommends increasing the toll rates for I-25 Segment 2 by 3% rounded up to the nearest \$0.05 for both AVI and LPT rates. Staff also recommends a more significant increase in the Southbound direction from 5:00 AM to 6:45 AM due to decreased speeds during these times. This increase would match the toll rates beginning at 6:45 AM. The proposed FY 2025-26 AVI and LPT toll rates for I-25 Segment 2, per the toll schedule, are shown in the tables below:

The multi-axle (4+) surcharge remains unchanged at \$25.

Recommended Adjustments to Toll Rates for I-25 Segment 3 (120th Ave to Northwest Pkwy/E-470) Express Lanes:

Based on the results of the toll rate adjustment analysis, staff recommends increasing the toll rates for I-25 Segment 3 by 3% rounded up to the nearest \$0.05 for both AVI and LPT rates. The proposed FY 2025-26 AVI and LPT toll rates for I-25 Segment 3, per the toll schedule, are shown in the tables below:

Recommended Adjustments to Toll Rates for C-470 Express Lanes:

Based on the results of the toll rate adjustment analysis, staff recommends increasing the toll rates for C-470 by 3% for both AVI and LPT rates. The proposed FY 2025-26 AVI and LPT toll rates for C-470, per the toll schedule, are shown in the tables below:

Multi-Axle (4+) Surcharge:

The multi-axle (4+) surcharge remains unchanged at \$25.

Recommended Adjustments to the Dynamic Pricing Algorithm Criterion for the Central 70 Express Lanes:

Based on the results of the toll rate adjustment analysis, staff recommends increasing the minimum toll cap for Central 70 by 3% rounded up to the nearest \$0.05 for both AVI and LPT rates. Staff is also recommending an increase to the maximum toll cap of \$0.50 due to decreased speeds during peak period times. The proposed AVI and LPT dynamic pricing criterion are shown in the table below:

License Plate Tolling (LPT) Surcharge:

There is no change to the LPT surcharge of 150% of the Central I-70 express lane AVI toll rates.

Multi-Axle (4+) Surcharge:

The multi-axle (4+) surcharge remains unchanged at \$25.

Recommended Adjustments to the Dynamic Pricing Algorithm Criterion for the I-25 South Gap Express Lanes:

Based on the results of the toll rate adjustment analysis, staff recommends increasing the minimum toll cap for I-25 South Gap by 3% rounded up to the nearest \$0.05 for both AVI and LPT rates. The proposed AVI and LPT dynamic pricing criterion are shown in the table below:

License Plate Tolling (LPT) Surcharge:

There is no change to the LPT surcharge of 150% of the I-25 South Gap express lane AVI toll rates.

Multi-Axle (4+) Surcharge:

The multi-axle (4+) surcharge remains unchanged at \$25.

Recommended Adjustments to the I-70 Mountain Express Lanes:

Based on the results of the toll rate adjustment analysis, staff recommend no changes in timeof-day toll rates or dynamic pricing criteria for the I-70 Mountain Express Lanes in either direction.

Options/Decision Matrix:

- 1. Staff Recommendation: Approve Resolution #472 adopting the proposed FY 2025-26 adjustments to time-of-day toll rates and dynamic pricing algorithm criterion.
- 2. Deny the request. Current time-of-day toll rates and dynamic pricing algorithm criterion would remain unchanged.

Next Steps:

• If adopted, the new toll rates would go into effect at 12:00 am on July 1, 2025, for all corridors except C-470, which will go into effect August 1, 2025.
