Parking:

Please park in either the northeast portion of the parking lot, or the small lot along W. Howard Place. The portion of the parking lot to the northeast of the building (closest to Mile High Stadium and along Morrison Road) is for RTD parking only, and you may be ticketed.

Transit Options:

CDOT Headquarters is across the street (W. Howard Place) from the Decatur-Federal Station on the W-Line of the light rail. The RTD 15L, 30 and 31 lines also stop at this location.

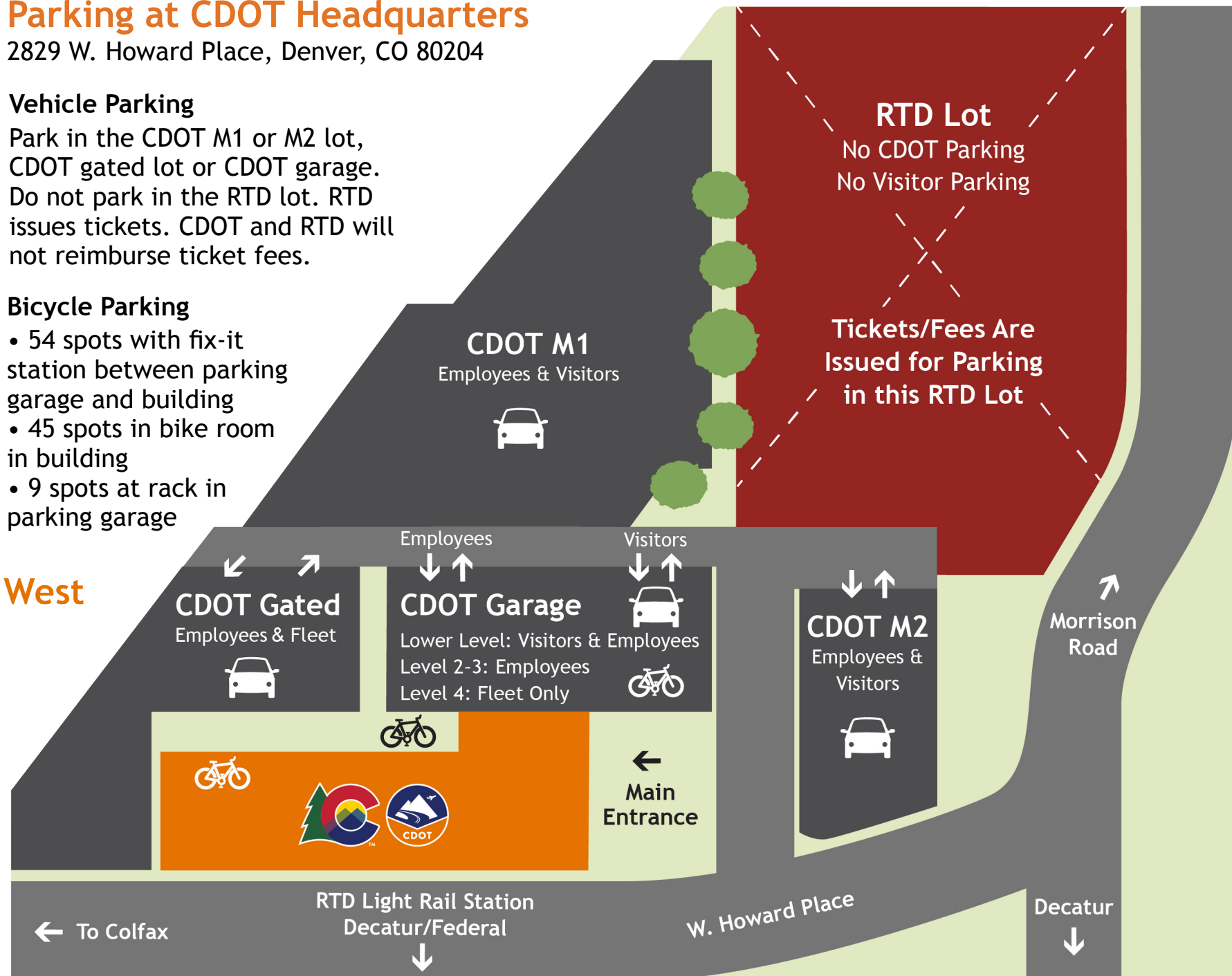
Vehicle Parking

Park in the CDOT M1 or M2 lot, CDOT gated lot or CDOT garage. Do not park in the RTD lot. RTD issues tickets. CDOT and RTD will not reimburse ticket fees.
