CDOT HQ News

There are some big projects and updates on the way from HQ, designed to improve MS4 compliance and productivity.

- CDOT's corrective action response log (CARL) is transitioning from ESCAN to 2nd Nature.
- General MS4 E-Learning is being developed for the training system on the LMS.
- A new Control Measure Selection and Design class is in development.
- TECS in-person classes plan to return Spring 2022. Virtual classes will be available until then. Come get TECS certified!
- Drone study underway to supplement the control measure inspection process. Keep an eye out for an upcoming presentation.

Getting Back to Normal

Like many others, CDOT has begun its return back to the office! This also means that CDPHE inspections of construction sites have resumed. Be on the lookout for these common Field and SWMP Findings:

Common Inspection Findings

Tom Boyce Water Quality Training Facility Renovation

In the summer of 2020, the TBWQTF was renovated. This facility was constructed to teach temporary control measure best management practices and Permanent Water Quality Design, Inspection, and Maintenance through field demonstrations. Students can learn in a state-of-the-art classroom, then hop outside to learn in field applications. With these recent renovations, the learning experience for CDOT's students is better than ever. We are excited to

get students back at the facility while considering health safety guidelines. Virtual TECS and SWMP classes are currently available and in-person classes are slated to resume in Spring 2022.

Possible Wood Storage

Be proactive when planning to use mulch on your construction site, as there are rumors of a possible wood mulch shortage. The Region Water Quality Staff can help with alternative strategies for control measures in the event of a wood mulch shortage.



EPA Proposes Changes to their Construction General Permit (CGP)

The 2022 CGP will include clarification of permit language and new permit requirements. Below is a list of important changes to the 2017 CGP:

- Clarify that perimeter controls are required in addition to establishing a natural buffer between construction activities and Waters of the U.S.
- Clarify how often inspections are required after multi-day storm events.
- Clarify that site maps must be updated following site inspection to reflect any changes to stormwater controls.
- Specify that inspections include checking for signs of sedimentation at points downstream that could be attributable to the discharge.
- Require photo documentation for stabilized site as part of permit termination.
- Add specificity to dewatering discharge requirements.
