

# 2026 Community Traffic Safety Grants Information Sheet

## Submission Deadline: January 30, 2026

### Project Background and Overview

The Colorado Department of Public Health (CDPHE) and the Colorado Department of Transportation (CDOT) invite applications for the 2026 Community Traffic Safety Mini-grant Initiative. This funding opportunity aims to support communities to implement data-informed, evidence-based approaches to address traffic safety issues for populations impacted by serious injury and fatal crashes.

### Funding Priorities

Priority will be given to first-time grantees and projects that focus on reducing serious injury and fatal crashes for the following populations:

- Young people/young drivers;
- Older people/older drivers; and
- Non-motorists, including pedestrians and bicyclists.

Additionally, **up to 1 project** focused on child passenger safety may be selected in this funding cycle, which must incorporate the following elements:

- Training new [certified Child Passenger Safety Technician\(s\)](#);
- Conducting car seat checks using the [National Digital Check Form](#) (NDCF); and
- Providing education to the public about car seat/booster safety.

### Funding Criteria

- Funding model: The Community Traffic Safety Mini-Grant is available through a reimbursement model, meaning project costs are reimbursed to grantees after completing and invoicing for the project. There is no required match.
- Eligibility: Public and non-profit entities representing a local community or Colorado region are eligible to apply.

- **Application Requirement:** The proposal must clearly use data to show a demonstrated community need. The proposal must also define how the applicant will develop and implement outreach, education, and/or programming promoting traffic safety strategies benefitting populations impacted by serious injury and fatal crashes.
- **Project Deadline:** All project activities, including expenses, must be completed by September 30, 2026.

## Budget Requirements

- **Available Funds:** There is \$30,000 total available funding. Applicants are able to request a minimum of \$5,000 and maximum of \$10,000 for project funding.
- All costs must be traffic safety related. The following materials costs are unallowable: food and candy; all clothing except reusable safety vests; swag items (ex. pens, keychains, stickers); giveaways or raffles; storage sheds; and furniture.
- Grantees have the right to claim an indirect rate but are not required to do so.
- If selected for funding, your organization will be required to complete a brief financial risk assessment (if one is not already on file with CDPHE).
- For child passenger safety applications:
  - Car seat purchases are limited to \$2,500.
  - Funding can be used to pay for Child Passenger Safety Technician certification training registration fee (\$95) and travel costs as well as supplies that will facilitate using the national digital check form (ex. tablet).

## Project Examples

Examples of applicable outreach, education, and/or programming strategies include but are not limited to:

- Young People/Drivers - Youth-led traffic safety campaign (see a [Colorado example](#)); peer-to-peer education programs; pilot program to increase access to driver's education; graduated driver's license education for drivers and parents.
- Older People/Drivers - Outreach and education events/programs to support driving fitness such as [CarFit assessments](#) or [Yellow Dot programs](#).
- Pedestrians, Bicyclist, and Non-motorists - Outreach and education events/programs around Walk and Bike to School Day (May) or Bike to Work Day (June); bicycle rodeos and providing education around helmet use/bicycle safety; educational media

campaign to promote walking/biking safety; Bicycle-friendly driver training; walk/bike/mobility audits paired with education and outreach; pedestrian safety outreach to schools and communities; e-bike and scooter education.

## Selection Criteria

Projects will be evaluated using the selection criteria below. The most successful projects will include a project idea that addresses a community need, demonstrates local support, focuses on priority populations, and is ready to be implemented.

Category	Description	Scoring (30)
Relevance	The project is relevant to the purpose of this funding.	1 - low 5 - high
Focus on priority populations	The project focuses on reducing serious injury and fatal crashes. Higher scoring will be given to projects that focus on young people/young drivers; older people/older drivers; and non-motorists, including pedestrians and bicyclists.	1 - low 5 - high
Community needs or barriers	The project clearly addresses a community traffic safety need or challenge. Higher scoring will be given to applications supported with relevant data, plans, or policies (ex. local transportation plan, Vision Zero or Safe Routes to School policy, Safety Action Plan, etc.).	1 - low 5 - high
Evidence-based strategies	The project relies on evidence-based project strategies to address a community traffic safety need or challenge.	1 - low 5 - high
Readiness to implement	The application demonstrates an ability to complete the project, with a feasible timeline, relevant partners, and realistic project details.	1 - low 5 - high
Evaluation plan	The application outlines an appropriate evaluation plan that incorporates qualitative and quantitative measures.	1 - low 5 - high

## How to Apply

An [electronic application](#) is available through Google Forms. The application includes an additional section for child passenger safety projects. PDFs of both [application versions](#) exist for your reference. In addition to the electronic application, applicants must submit a project budget via email to Molloy Sheehan, [molloy.sheehan@state.co.us](mailto:molloy.sheehan@state.co.us). Applicants may use the [budget template](#) or create their own. The budget form must explain all expenses included. Applicants are responsible for ensuring the calculations in the budget are accurate.

All application materials must be submitted electronically via the [Google Form application](#) no later than 11:59 p.m. on January 30, 2026.

## Funding Timeline

- January 30, 2026 - Application deadline
- Week of February 23, 2026 - Applicants will be notified of funding decisions
- September 30, 2026 - Project activities must be completed.
- October 15, 2026 - Project invoice materials must be submitted to CDPHE.
- October 31, 2026 - Project evaluation must be completed.
