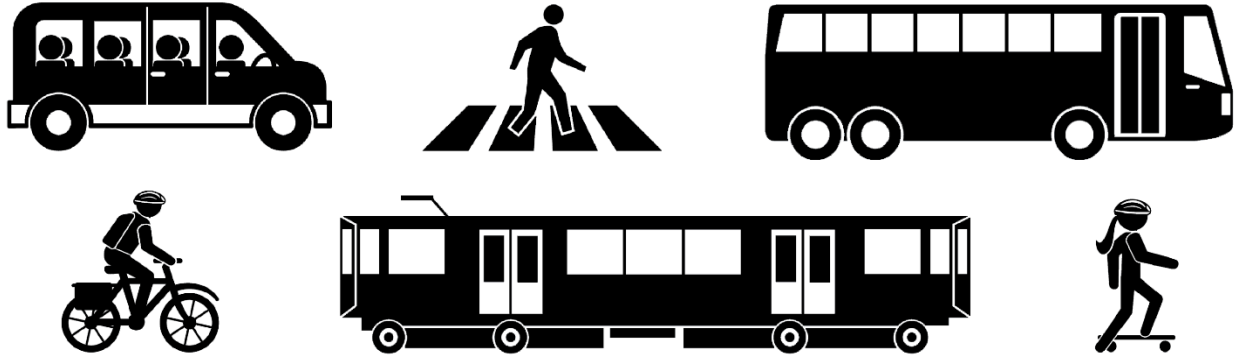


# State of Colorado Transportation Demand Management (TDM) Conference - Agenda
