## PUBLIC INVOLVEMENT

Public Involvement for the development of the FY2025 – FY2028 STIP is carried out in accordance with 23 CFR 450.210. Public involvement plays an important part in STIP development. CDOT's Project Priority Programming Process, or 4P, has been established to meet and support federal requirements regarding the development of the STIP. Further, CDOT utilizes <u>A Guide to the Transportation Planning</u> and Programming Public Involvement Process as its guidebook for implementing public involvement for the entire planning process, including the development of the STIP.

Public Involvement for the FY2024 – FY2027 STIP kicked off on April 15, 2024 and closed on May 15, 2024.

### **STIP Public Hearing**

A Public Hearing was held with the Transportation Commission on April 18 during the Commission's regular meeting at CDOT Headquarters. No comments were submitted during the public hearing.

## **Other Comments**

The Denver Regional Council of Governments submitted a comment requesting the updated inclusion of four projects. These projects have been updated in the current project list:

- SDR6744.074 US-40 Complete Streets
- SDR9000.045 South Platte River Trail Mississippi to Florida
- SR17012.086 CO7 Preliminary and Environmental Engineering
- SR19000.001 Lone Tree Mobility Hub

The City of Canon City requested scope information for two projects. CDOT Region 2 planning staff provided the information to Canon City.

Jon Girand requested information for how CDOT handles implementation of the EPA MOVES program with the STIP. CDOT Environmental Branch staff provided a response to Mr. Girand. In summary, the STIP is a plan document and is not modeled for EPA compliance. Compliance is modeled at the project level itself. CDOT currently uses EPA's MOVES 4 standards for project compliance.
