SUBJ: Notice of Funding Opportunity

I am writing to inform you that the CDOT Division of Transit and Rail (DTR) is releasing a Notice of Funding Availability (NOFA) for its 2019 Consolidated Call for Capital Projects (CCCP). The NOFA will announce the availability of over \$32 million in federal and state funds for transit capital projects—which includes vehicles, facilities, equipment and major engineering studies. Funding is available for both public and specialized transportation. Funding is not available for operating or administrative costs.

Recent sub-recipients of CDOT transit funding will automatically receive a copy of the upcoming NOFA. However, there may be organizations who are not aware of this funding opportunity. **If you are aware of any organization that could potentially be interested in this funding opportunity**, please inform them so that DTR can promptly provide them the NOFA and necessary application materials. Grant applications will be due the first week of December, so prompt notification will be helpful.
