

# **Current Conditions and Accomplishments**



The US 50 Blue Mesa Bridge was closed between Mile Point 136 and MP 140 in April 2024 due safety reasons stemming from a crack in the high-strength steel. Repairs were conducted in phases.

- **Phase I:** fixing cracks in four areas posing an imminent risk to structural integrity; completed in July 2024; bridge opened to smaller vehicles and emergency services.
- Phase II: repairs completed; bridge reopened in fall 2024.
- **Phase III:** priming and painting; complete by end of July 2025.

The US 50 - US 285 intersection project, located near Poncha Springs, made significant improvements to better accommodate the increased volume of traffic that uses this intersection.

- Realignment and reconstruction of the existing three-way configuration into a four-way signalized intersection
- Lengthening of the right turn-lane from westbound US 50 to northbound 285 allowing for better traffic flow
- Resurfacing of seven miles of roadway on US 50 from the US 50 - US 285 intersection to Maysville
