Why is the project needed?

The purpose of this Project is to improve corridor travel reliability and safety, reduce recurring congestion, decrease travel delay, and improve operational performance on C-470 between Wadsworth Boulevard and I-70.

What is the Project Area?

The project covers C-470 from Wadsworth Boulevard to the I-70 interchange. The area is depicted here.

What improvements are being considered?

Potential corridor improvements include:


- Safety and operational improvements in all lanes
- Express lanes through the corridor
- Improvements to interchanges along the corridor
- Wildlife crossings
- Environmental mitigation
- Technology and system management upgrades
- Bicycle and pedestrian improvements.

What is the Project Status?

- The project is currently working towards the preliminary design and environmental analysis phase. The design team is working in parallel with an HPTE Level 2 Traffic and Revenue study through 2020 to advance the concept design of the Proposed Action prior to NEPA.
- NEPA has not yet been initiated.

What is the current project timeline?

The current project timeline is depicted here:





