

# Colorado and Sheridan Boulevards intersection safety improvements project begins mid-May

### Project anticipated to last through February 2022

## **PROJECT OVERVIEW**

In mid-May, the Colorado Department of Transportation and contractor Lumin8 will begin an intersection safety improvements project along Colorado and Sheridan Boulevards in Denver. The project will improve traffic flow and safety for motorists and pedestrians at 12 different intersections (see below for intersection details). The project includes bringing curb ramps to Americans with Disabilities (ADA) compliance, modernizing traffic signals, and installing raised medians at select locations.

#### PROJECT SCHEDULE

Work is scheduled to begin in mid-May and continue through February 2022. However, these operations are weather and temperature dependent, and this schedule could change.

#### TRAVEL IMPACTS


- Various single lane closures will be in effect from 8:30 a.m. 3:30 p.m. Mondays through Thursdays, and 8:30 a.m. 2:00 p.m. on Fridays.
- Occasional night and weekend work is possible. Please visit the project website for weekly schedule information.
- Sidewalks may be temporarily closed during construction. Pedestrian detours will be in place.
- Please drive safely through the work zone when crews are present.


#### **PROJECT BENEFITS**

- Upgrading traffic signals will improve the traveling experience for motorists and pedestrians
- Bringing curb ramps to ADA compliance will increase safety for pedestrians
- Raised medians help to decrease the rate and severity of car crashes and reduce vehicle speeds

- 5. Sheridan Blvd & W 1st Ave: Traffic signal improvements, ADA ramps
- 6. Sheridan Blvd & W 14th Ave: Traffic signal improvements, ADA ramps
- 7. Sheridan Blvd & W 16th Ave: Raised median installation
- 8. Sheridan Blvd & W 32nd Ave: Traffic signal improvements, ADA ramps
- 9. Sheridan Blvd & W 38th Ave: Traffic signal improvements, ADA ramps
- 10. Sheridan Blvd & W 44th Ave: Traffic signal improvements, ADA ramps
- 11. Sheridan Blvd & W 46th Ave: Traffic signal improvements
- 12. Sheridan Blvd & Wellington Pwky: Raised median installation
