

Current Design Work

- Landscaping & irrigation plans nearing completion

Current Construction

- Deck replacement on the northbound I-25 bridge over Indiana Ave completed
- Work is nearing completion on the rehabilitation of Mesa Ave. over I-25
- Piers & pier caps for the CML bridge over the railroad complete & abutment

Final Phase of Northern Avenue Bridge Rehabilitation Underway

Crews have been busy on the Northern Avenue bridge over I-25 since February as the I-25/Ilex team prepares to head into the last phase of the rehabilitation process. Prior to this final phase of construction, the I-25/Ilex team will open all four lanes of traffic for the Colorado State Fair (August 25 through September 4) to help ease traffic congestion during the Fair.

Beginning early September, traffic on Northern Avenue will switch to the south portion of the bridge so the last phase of work can be completed. The rehab work will remove the existing sidewalk on the north side of the bridge, therefore pedestrians will not be able to access the Northern Avenue bridge during construction. All pedestrian traffic will be detoured to the Mesa Avenue bridge over I-25 until early November.

Upon completion, Northern Avenue bridge over I-25 will feature:

- Rehabilitated bridge structure
- Four newly refurbished lanes of traffic with better roadway transition
- New bridge railing and guardrail
- Widened sidewalk for increased pedestrian safety and access
- Wider shoulders
- Pedestrian railing

- Improved lighting, signing, striping and landscaping

Improved D Street Intersection Complete and Open for Traffic

Clark Street reopened last week as a cul-de-sac to improve the previous five-way intersection with D Street. In addition, new drainage was installed, with new curb, gutter and sidewalks added and new asphalt pavement.

"Now D Street Intersection operates as a true four-way intersection instead of having a fifth street introduced," said Mike Blasi, project manager for Flatiron Constructors, Inc. "This will make the intersection much safer for both motorists and pedestrians."

Clark Street now also has improved pedestrian access with ADA accessible ramps and dedicated crossings.

The new intersection was designed to accommodate current and future traffic demands, and reduce the potential for accidents.

What the Project Involves


The Ilex interchange is the first segment to be constructed as part of the New Pueblo Freeway.

The project consists of replacing bridges on I-25 between Ilex Street and City Center Drive in Pueblo.

In many cases, bridge construction can shut down busy freeways. Minimizing road closure time is always a priority in bridge design and project planning. Using prestressed concrete girders helps reduce road closure time by offering ready-to-install materials upon delivery. But it is still far from a simple process.

The first challenge is transporting girders to the bridge site. Girders can be as long as 168' and weigh up to 194,000 lbs. Taking into account a typical semi-trailer truck is 53 feet long, transporting girders is a daunting task.

Using special steerable trailers, delivery trucks can make turns that would otherwise be impossible. Driving speeds of around 45mph, the trucks are also accompanied with two escort vehicles to ensure safe travel.

Upon arrival, a girder is staged into place where cranes will best be able to lift them. Rigging is then placed around the girder, which is basically a tie-off line for worker safety. Once the rigging is complete, cranes are brought into position and cables are lowered down to connect to the girder.

At this point, once everyone is clear, the girder is unhooked from the trailer so the cranes can lift the girders and move them into place. Generally, crane operators can set the girders into place within less than half an inch of where they need to be!

Work includes rehabilitation of bridges on northbound I-25 over Santa Fe Avenue (US 50C), I-25 over Indiana Avenue, on the Santa Fe Avenue (US 50C) bridge over the Arkansas River, and on Northern Avenue and Mesa Avenue over I-25.

Structurally deficient bridges on I-25 over Gruma Drive, the Union Pacific Railroad, and Ilex Street will also be removed and replaced.

Interchange ramps will be lengthened to provide safer transitions onto and off of the Interstate, especially the 1st Street ramp to southbound I-25. Roadway curves will be softened to improve visibility and provide a smoother ride for motorists.

Local roadway improvements are included at D Street, Ilex Street, Bennett Street cul-de-sac, Clark Street cul-de-sac, and along Santa Fe Avenue.

Bridges will be widened at City Center Drive and I-25 over Santa Fe Avenue (widened to the median).

Noise abatement will also occur along some segments of I-25.

Once set in place, but before the crane's cables are removed, the team braces the girders so they do not shift or fall. The crane is unhooked from the girder, and moves to pick up the next one.

The entire process generally takes from 20 to 60 minutes per girder. Approximately one week later, the team does what is known as a closure pour, or what an average person might call "gluing" the girders together.

Most recently, girders were set at the location of Gruma and I-25 where two cranes lifted girders over Gruma and into place. At a safe distance, seeing girders being set is a fascinating process to watch!
