



US 24 REPAVING FROM MANITOU SPRINGS TO CHIPITA PARK

PROJECT OVERVIEW

PROJECT OVERVIEW

Colorado Department of Transportation and its contractor, Martin Marietta Materials, are partnering on a project that will improve 5.09 miles of US 24 in El Paso County between Manitou Springs and Chipita Park. Work consists of removing and replacing asphalt, upgrading concrete curb and gutter, and replacing damaged guardrail and delineator posts.

The improvements will increase safety, and asphalt resurfacing will provide motorists a smoother road surface.

Martin Marietta Materials was awarded the \$5.4 million bid for this project by CDOT.

PROJECT SCHEDULE

Work will begin the week of Monday, May 18, and the project is expected to be completed in early fall of 2020.

Crews will conduct concrete work to replace curb and gutters before asphalt repaving, and replace guardrail and delineators after the resurfacing process. Work will progress on the eastbound side of US 24 from just west of Chipita Park to Manitou Springs, and then on the westbound side of the highway.

Through the month of May, crews will be conducting concrete curb and gutter repairs from 9 a.m. to 7 p.m., Monday through Friday.

The asphalt repaving work is scheduled to begin in early June and will be done overnight from 7 p.m. to 5 a.m., Sunday through Thursday.

No work is expected on weekends or major holidays. Construction schedules are weather sensitive and are subject to change.

TRAFFIC IMPACTS

Motorists can expect highway shoulder and single lane closures during working hours. Speeds will be reduced to 45 mph in the work zone. Delays up to 15 minutes can be expected. Lane reduction times and dates may fluctuate.



COVID-19

With that in mind, road maintenance and construction continues on CDOT projects with social distancing and other health safety measures to reduce COVID-19 exposure on the worksite.
