- Public hearing provides opportunity to learn about Final EIS and to gather public input














US 36 Project Area





Purpose and Need

Project No. NH 0361-070(14133)

 Purpose: Improve mobility along US 36 from I-25 in Adams County to Foothills Parkway/Table Mesa Drive in Boulder and among intermediate destinations



Purpose and Need

- Needs:
 - Increase trip capacity
 - Expand access
 - Provide congestion relief
 - Expand mode of travel options
 - Increase efficiency of transit service
 - Update outdated highway facilities







- Comment period held from August 3 – September 17, 2007
 - Minimize community and environmental impacts
 - Property acquisition, noise, access
 - Minimize project costs
 - Increase mobility improvements



Preferred Alternative Committee Process

- Twenty-one member group of agencies and jurisdictions
- Purpose was to identify a preferred alternative and phasing strategies for the US 36 Final EIS
- Addressed public comments and outstanding issues from Draft EIS

- Final EIS Alternatives
 - Package 1
 - Package 2
 - Package 4

 Combined Alternative Package (Preferred Alternative)



- Package 1: No Action
 - FasTracks improvements
 - 120th Avenue Connection
 - 80th Avenue Bridge
 - Queue jumps at McCaslin, Interlocken and Church Ranch



Project No. NH 0361-070(14133)

Package 2

- Two barrierseparated managed lanes
- Median Bus Rapid Transit (BRT) stations
- Cost = \$1.8 billion

Package 4

- One generalpurpose lane
- One bufferseparated BRT/HOV lane
- Median BRT stations
- Cost = \$1.6 billion



- Preferred Alternative
 - Add one buffer-separated managed lane in each direction
 - Auxiliary lanes between most interchanges
 - Ramp and side loading BRT stations
 - Improvements to all interchanges
 - Transportation Demand Management
 - Bikeway from Westminster to Boulder
 - Cost = \$1.3 billion



Preferred Alternative Transit Elements

- Ramp Stations with HOV Bypass Lanes
- BRT Service; Express and Local
- Corridor BRT Stations
 - Westminster Center
 - Church Ranch/104th Avenue
 - 116th Avenue
 - Flatiron
 - McCaslin
 - Table Mesa





Preferred Alternative Highway Elements



- Managed lane access points between each interchange
- Auxiliary lanes
 between most
 interchanges
- Interchange
 improvements at nine
 locations
- Replace aging infrastructure



Resolution of Broadway Access

- Comments at April 2009 public meetings
- Follow-up discussion with Adams County and Save Your Neighborhood Access (SYNA)
- Process and Final EIS language approved by Adams County and SYNA
 - No changes to access in Phase 1
 - Separate study to evaluate local access will be done before any action occurs regarding this interchange



Preferred Alternative Bikeway Elements



- Continuous commuter bikeway from Boulder to Westminster
- Grade separations
 at major crossings
- Facilitates local connections



Preferred Alternative Benefits

- Multi-modal travel options
- Improve travel times
- Offer expanded transit services (BRT)
- Provide added person-trip capacity
- Reduce the number of highly congested general-purpose lane segments
- Make improvements to US 36 interchanges
- Have lower number of congested intersections at the grade-separated interchanges



Preferred Alternative Impact Comparison

- Right-of-way impacts reduced 70%
- Similar noise impacts and mitigation strategies
- Fewer parks and open spaces
 impacted
- Wetland and wildlife impacts reduced
- Local street improvements at specific locations
- Other resources have similar impacts



Environmental Impacts Right-of-Way

- Right-of-Way (ROW) Impacts (full and partial)
 - ROW impacts to business properties:
 - P2: 138 relocations
 - P4: 135 relocations
 - PA: 24 relocations
 - ROW impacts to residential areas:
 - P2: 201 residences
 - P4: 202 residences
 - PA: 65 residences





Environmental Impacts Right-of-Way

- ROW Acquisition Process used by CDOT and RTD
 - Follows Uniform Relocation Act
 - Provides for fair market appraisal and purchase price negotiation
 - Assistance with relocation provided
 - Assistance to renters as well as owner-occupied
- ROW Agent is here to answer questions



Environmental Impacts Noise

- Impacts
 - No Action impacts 114 residences
 - Preferred Alternative impacts 135 residences
 - No commercial uses impacted
- Mitigation
 - Replace existing sound mitigation where disturbed
 - Provide new sound mitigation where reasonable and feasible
 - Madison Hills Homes
 - Tuscany Trail
 - Wadsworth Boulevard
 - Rock Creek Apartments
 - Apache Court/Pima Court
 - Moorhead Avenue to Bear Canyon Creek



Preferred Alternative Phasing

- Preferred Alternative cost is \$1.3 billion
- Regional plan has \$711 million for US 36 through 2035
- Due to funding limitations project will be phased
- Phase 1 implementation will be focus of federal agency decision
- Other phases to be implemented later



Preferred Alternative Phase 1

- Build managed lane from Federal Blvd. to Boulder
- Enhance BRT
 stations and service
- Reconstruct Sheridan and Wadsworth Parkway interchanges
- Replace Lowell and 112th Avenue bridges
- Rehabilitate and widen pavement
- Construct bikeway between Boulder and Westminster






