# US 550 at US 160 Supplemental Environmental Impact Statement Public Involvement Plan (June 2011)

## **Key Issue**

The Colorado Department of Transportation and Federal Highway Administration completed an Environmental Impact Statement (EIS) for the US 160 between Durango and Bayfield in 2006. The process involved extensive public involvement efforts, including the required public hearing and comment periods. CDOT recognizes the important need to educate and involve the public in the process of conducting a Supplemental EIS (SEIS), which focuses on the connection of US 550 to US 160 in Grandview, east of Durango. For the purpose of this Public Involvement Plan, the term "stakeholders" will include interested and affected parties both internal and external to CDOT (identified below).

## **Objectives**

- Provide stakeholders with background information on the initial EIS process and results, as well as the current interchange construction project
- Provide stakeholders with information regarding the purpose and need for an SEIS
- Provide stakeholders with information regarding the SEIS process and their opportunity for involvement
- Provide stakeholders with information on interchange project purpose and need, as well as SEIS alternatives, so they may make informed decisions
- Utilize existing communication channels to share SEIS process information
- Work together with agency partners to identify and respond to stakeholder concerns

## Approach

To achieve these objectives, CDOT will follow the Public Involvement steps outlined in the CDOT NEPA Manual, December 2008.

# Background

CDOT began design of the US 550 connection in 2007 and discovered a gas well had been constructed in the selected alignment since final EIS surveys had been completed. CDOT mapped a new alignment that avoided the gas well. In reviewing this alignment, CDOT and the Federal Highway Administration (FHWA), in consultation with the State Historic Preservation Office, determined that a portion of the ranch where US 550 was to cross is eligible for the "National Register of Historic Places" (the approach taken to identify historic sites had changed since the Record of Decision was signed, requiring new analysis.) In 2009, FHWA and CDOT began a reevaluation process to look at US 550 alignments that avoid or minimize impacts to the four historic ranches and other cultural sites. Five alternatives for a US 550 connection to US 160 were reexamined through a federal Section 4(f) process. In spring 2011, this process resulted in a *draft* document showing that the alignment identified in the original 2006 Record of Decision (modified to avoid a gas well) is still the least impactful to historic and archaeological

sites. However, CDOT and FHWA are conducting an SEIS, a more extensive evaluation of the alternatives.

#### Stakeholder Identification

CDOT has identified several stakeholder groups that could be affected by project construction. We will focus our public notification tools on reaching these groups to ensure comprehensive notification:

- Distribute, by hand, Draft SEIS NOA/Public Hearing postcards as necessary, including those translated in Spanish
- Place paid advertisement for Draft SEIS NOA and Public Hearing in Durango Herald

# Q. Why is the US 550 connection being reconsidered?

A. In 2007, CDOT began design of the US 550 connection to US 160, as called for in the 2006 Environmental Impact Statement (EIS) Record of Decision (US 160 EIS). During design, CDOT discovered a gas well had been constructed in the selected alignment since final EIS surveys had been completed. CDOT designed a new alignment that avoided the gas well. In reviewing this alignment, CDOT and the Federal Highway Administration (FHWA), in consultation with the State Historic Preservation Office, determined that a portion of the ranch where US 550 was to cross is eligible for the "National Register of Historic Places," as were three other ranches on the mesa.

# Q. Was this historic ranch considered in the initial study?

A. As part of the original EIS process, this area had been surveyed for individual historic structures. Since then, the national trend in historic preservation is to consider landscapes—such as ranches and farms as a whole—in addition to individual architectural structures. So while CDOT and FHWA met all of the existing requirements during the EIS process, the approach taken to identify historic sites had changed since the Record of Decision was signed, requiring new analysis. There are four historic landscapes on the mesa.

# Q. What has happened to address a US 550 connection so far?

A. In 2009, FHWA and CDOT began a reevaluation process to look at US 550 alignments that avoid or minimize impacts to the four historic landscapes and other cultural sites. Five alternatives for a US 550/US 160 connection were reexamined through a federal Section 4(f) process. In spring 2011, this process resulted in a draft document (available on CDOT's web site) showing that the alignment identified in the original 2006 Record of Decision (modified to avoid a gas well) is still the least impactful to historic and archaeological sites. Then, CDOT and FHWA initiated the development of a Supplemental Draft Environmental Impact Statement (SDEIS). The SDEIS revisits only the US 550 south connection to US 160, not the entire US 160 corridor. CDOT and FHWA are supplementing the existing 2006 EIS to address the newly identified impacts to historic and archaeological sites and any other changes related to the connection of US 550—both natural and manmade, including regulatory. The SDEIS (LINK) is available for review and public comment through November 28, 2011. This draft document evaluates three reasonable alternatives for a US 550 connection based on whether they meet purpose and need requirements for highway improvements (capacity, safety and access), as well as cost and logistical factors.

# Q. What are the US 550 connections being considered?

A. The alternatives evaluated in the Supplemental Draft Environmental Impact Statement (SDEIS) are: 1) Revised G Modified, the 2006 Record of Decision Preferred Alternative (with a slight alignment shift), which would realign US 550 to connect at the current interchange; 2) Revised F Modified, which connects at Three Springs Blvd.; and 3) Eastern Realignment, which also connects at Three Springs Blvd. Alternatives can be viewed here: <a href="http://www.coloradodot.info/projects/us550-at-160/us-550-alternatives.">http://www.coloradodot.info/projects/us550-at-160/us-550-alternatives.</a>)

## Q. Which connection is the Preferred Alternative in the SDEIS?

**A.** Revised G Modified, the 2006 Record of Decision Preferred alternative (with a slight alignment shift to avoid a gas well), which would realign US 550 to connect at the current interchange. This alternative is shown in the draft document to have the least impacts to residents and businesses, to irrigated farmland, to wildlife habitat, to wetlands and to historic sites (see map at: <a href="http://www.coloradodot.info/projects/us550-at-160/us-550-alternatives/alt-g-exhibit-1-1r.pdf/view.">http://www.coloradodot.info/projects/us550-at-160/us-550-alternatives/alt-g-exhibit-1-1r.pdf/view.</a>)

# Q. Which alignments were not evaluated in the SDEIS?

A. Alternatives not evaluated in detail in the SDEIS include a western realignment, and several alternatives utilizing the existing US 550 alignment and its current connection with US 160 (known locally as Farmington Hill). It was determined that these alternatives do not meet the purpose and need requirements (capacity, safety, access) or other screening criteria (cost, logistics). Additionally, a 'No Action' alternative was analyzed that would keep US 550 on its current alignment, where poor geometry, low design speeds and two-lane capacity on a north-facing steep grade presents both capacity and safety issues This alternative is evaluated in the SDEIS to provide a benchmark for comparison of the environmental impacts.

# Q. Where can I get more information on the draft document?

A. The document is available to the public at Durango, Bayfield and Ignacio public libraries, San Juan Public Lands Center, City of Durango, La Plata County and CDOT's main Durango office (address below). The 45-day public comment period will end on November 28. ## Q. How can I make comments on the document?

**A.** Now that a Draft SEIS is prepared, a public hearing will be held on November 2, 2011, from 5 to 8 PM at Escalante Middle School (141 Baker Lane) in Durango. ## Q. When will a final decision about a US 550 connection be made?

A. Following incorporation of public comments, a Final EIS will be prepared, and the Federal Highway Administration will produce a Record of Decision on a US 550/US 160

# Q. Is an interchange needed if US 550 does not connect there?

A. Yes. Not one, but three interchanges are actually called for in the 2006 EIS Record of Decision (posted on CDOT's web site). Traffic modeling and area development projections for the original EIS were completed in coordination with the City of Durango and La Plata County, using—among other resources—the city's "2004 Grandview Area Plan." Traffic studies show a traffic signal on this section of highway would fail by 2025—or at full planned development build-out.

In 2009 on peak travel days, an average of 27,875 vehicles traveled this stretch of highway through Grandview. Traffic projections show that by 2030, 44,478 vehicles will travel US 160 on peak travel days near the interchange; factoring in future development laid out in the Grandview Area Plan, this number is 85,910 vehicles per day in 2030 during peak season travel (these numbers are conservative, and consider the current economic downturn).

# US 160 GRANDVIEW INTERCHANGE AND A US 550 CONNECTION TO US 160

# What's the update on interchange construction?

We're nearing completion. CDOT began to construct a second westbound lane into Durango and the US 160 Grandview Interchange back in July 2008. The final phase of construction started in March 2011 and will complete a fully-functional interchange by late 2011. Upon completion, the new US 160 interchange will allow safer access to and from the south-side properties via a frontage road and, eventually, provide safer access to future development to the north.

# How much does the interchange cost and what does that include?

The total cost of the interchange is estimated at under \$47 million. That cost includes the addition of a second westbound lane through Grandview; four interchange bridges and bridge ramps; a 2,020-foot bike/pedestrian path; six highway retaining walls and four path retaining walls; a concrete roundabout on the north side; new access road on the south side; extensive drainage improvements and environmental mitigation.

# Will there be a connection with US 550 at this interchange?

Maybe. US 550 may or may not connect to US 160 at this interchange, pending the results of an environmental process currently underway. (Please see next page.)

# How was the original US 550 connection determined?

An Environmental Impact Statement (EIS) for the US 160 between Durango and Bayfield began in 2002 and was completed in 2006. The EIS Record of Decision called for highway widening and identified the need for three interchanges for US 160 through the Grandview area (including the current interchange, where US 550 was to connect).

# Why is the US 550 connection being reconsidered?

CDOT began design of the US 550 connection in 2007 and discovered a gas well had been constructed in the selected alignment since final EIS surveys had been completed. CDOT mapped a new alignment that avoided the gas well. # When will a final decision about a US 550 connection be made?

In early 2012. FHWA is requiring that a Supplemental EIS be completed (SEIS). This SEIS will revisit *only* the alignment and connection of US 550 to US 160, not the entire US 160 corridor. CDOT and FHWA will supplement the existing 2006 EIS to address the newly identified impacts to historic and archaeological sites and any other changes related to the connection of US 550—both natural and manmade, including regulatory.

# How can the public get involved?

Once a Draft SEIS is prepared, there will be a public hearing held in the fall, followed by a public comment period (notice will be sent via media outlets, CDOT web site, postcard to residents in and near Grandview). Then a Final EIS will be prepared, and a Record of Decision will be made by the FHWA on a US 550 connection with US 160.

# Is an interchange needed if US 550 does not connect there?


Yes. Not one, but three interchanges are actually called for in the 2006 EIS Record of

Decision (posted on CDOT's web site). Traffic modeling and area development projections for the original EIS were completed in coordination with the City of Durango and La Plata County, using—among other resources—the city's "2004 Grandview Area Plan." Traffic studies show a traffic signal on this section of highway would fail by 2025—or at full planned development build-out.

In 2009 on peak travel days, an average of 27,875 vehicles traveled this stretch of US 160 through Grandview. Traffic projections show that by 2030, 44,478 vehicles will travel US 160 on peak travel days near the interchange. When the traffic from the adopted Grandview Area Plan is added, this number grows to 85,910 vehicles per day in 2030 during peak season travel (these numbers are conservative, and consider the current economic downturn).



US 160 Grandview Interchange Phase III, the final phase, includes construction of a frontage road on the south side.



US 160 Grandview Interchange – Construction of the final phase (yellow) is underway and will complete a fully-functional interchange by late 2011.

# US 550 South Connection to US 160 Supplemental Draft Environmental Impact Statement

#### **PUBLIC BRIEFING:**

**US 160 Environmental Impact Statement (EIS)** - The Environmental Impact Statement (EIS) for the US 160 corridor between Durango and Bayfield was begun in 2002. This EIS included alternatives for a connection with US 550. The EIS Record of Decision (ROD) was completed in November 2006, following an extensive public involvement process. The ROD called for widening the highway to four lanes between Bayfield and Durango and constructing three grade-separated interchanges on US 160 through the Grandview area, one of which would connect with a newly aligned US 550 just east of the current junction.

Reevaluation of a US 550 connection - In 2009, the Federal Highway Administration and CDOT began a reevaluation process to look at US 550 alignments that would avoid or minimize impacts to the four historic ranches and other cultural sites. Seven action alternatives for a US 550/US 160 connection (including three alternatives on the existing US 550 alignment) were reexamined through a federal Section 4(f) process. In spring 2011, this process resulted in a *draft* 4(f) document showing that the alignment identified in the original 2006 Record of Decision (modified to avoid a gas well) is the least impactful to historic and archaeological sites.

**Supplemental Draft EIS** - In early 2011, CDOT and FHWA began a more extensive evaluation of the alternatives for a US 550/US 160 connection: a Supplemental EIS (SEIS). This SEIS revisits *only* the alignment and connection of US 550 to US 160, not the entire US 160 corridor. CDOT and FHWA have supplemented the existing 2006 EIS to address the newly identified impacts to historic and archaeological sites and any other changes related to the connection of US 550—both natural and manmade. The Supplemental Draft EIS (SDEIS) evaluates three reasonable alternatives for a US 550 connection based on whether they meet purpose and need requirements for highway improvements (capacity, safety and access), as well as cost and logistical factors.


The alternatives evaluated are: 1) Revised G Modified, the 2006 Record of Decision Preferred Alternative (with a slight alignment shift), which would realign US 550 to connect at the current interchange—the SDEIS identifies this alignment as the Preferred Alternative; 2) Revised F Modified, which connects at Three Springs Blvd.; and 3) Eastern Realignment, which also connects at Three Springs Blvd. (see attached map).

Alternatives not evaluated in detail in the SDEIS include a western realignment, and several alternatives utilizing the existing US 550 alignment and its current connection with US 160 (known locally as Farmington Hill). It was determined that these alternatives do not meet the purpose and need requirements (capacity, safety, access) or other screening criteria (cost, logistics). Additionally, a 'No Action' alternative was analyzed that would keep US 550 on its current alignment, where poor

geometry, low design speeds and two-lane capacity on a north-facing steep grade presents both capacity and safety issues This alternative is evaluated in the SDEIS to provide a benchmark for comparison of the environmental impacts.

The Final Step - A Supplemental Draft Environmental Impact Statement (SDEIS) is complete. The document is available to the public and comments will be accepted through the 45-day public comment period ending on November 28, 2011. A public hearing will be held on November 2 at Escalante Middle School in Durango (5:00 to 8:00 PM) at 141 Baker Lane. Following incorporation of public comments, a Final EIS will be prepared, and the Federal Highway Administration will produce a Record of Decision on a US 550/US 160 connection in the spring of 2012.

# US 160 Interchange & a US 550 Connection in Grandview East of Durango - La Plata County, 2011

**US 160 Interchange Project History** - The Environmental Impact Statement (EIS) for the US 160 corridor between Durango and Bayfield was begun in 2002. This EIS included alternatives for a connection with US 550. The EIS Record of Decision (ROD) was completed in November 2006, following an extensive public involvement process. The ROD called for widening the highway to four lanes between Bayfield and Durango and constructing three grade-separated interchanges on US 160 through the Grandview area, one of which would connect with a newly aligned US 550 just east of the current junction.

CDOT began design of the US 550 connection in 2007 and discovered a gas well had been constructed in the selected alignment since final EIS surveys had been completed. CDOT mapped a new alignment that avoided the gas well. In reviewing this alignment shift, CDOT and the Federal Highway Administration (FHWA), in consultation with the State Historic Preservation Office (SHPO), determined that four ranches on the mesa were eligible for the "National Register of Historic Places."

Why was the 'Historic Places' determination not made before? As part of the original EIS process, this area had been surveyed for individual historic structures. Since then, the national trend in historic preservation is to consider landscapes—such as ranches and farms—as a whole, in addition to individual architectural structures. So while CDOT and FHWA met all of the existing requirements during the original EIS process, the approach taken to identify historic sites had changed since the Record of Decision was signed, thus requiring new analysis.

US 160 Grandview Interchange Construction - CDOT began construction of a second westbound lane into Durango (between the new Three Springs Blvd. and the current US 550 intersection) and the first phase of the US 160 Grandview interchange in July 2008. CDOT subsequently added the two remaining phases of interchange construction. With the third and final phase wrapping up this November, the new interchange will allow safer access to and from the south-side properties via a frontage road and provide safer access to future development to the north. The total cost of the interchange is estimated at under \$47 million. The cost includes the addition of a second westbound lane through Grandview; four interchange bridges and bridge ramps; a 2,020-foot bike/pedestrian path; six highway retaining walls and four path retaining walls; a concrete roundabout on the north side; new access road on the south side; extensive drainage improvements and environmental mitigation.

**Need for the Interchanges** - Three interchanges are called for in the original US 160 EIS Record of Decision (2006). Traffic modeling and area development projections (which have recently been updated for the Supplemental Draft EIS) were completed in coordination with the City of Durango and La Plata County, using—among other resources—the city's "2004 Grandview Area Plan."

In 2009 on peak travel days, an average of 27,875 vehicles traveled this stretch of US 160 through Grandview. Traffic projections show that by 2030, 44,478 vehicles will travel US 160 on peak travel days near the interchange. When the traffic from the adopted Grandview Area Plan is added, this number grows to 85,910 vehicles per day in 2030 during peak season travel (these numbers are conservative, and consider the current economic downturn).

Reevaluating a US 550 connection - In 2009, FHWA and CDOT began a reevaluation process to look at US 550 alignments that would avoid or minimize impacts to the four historic ranches and other cultural sites. The Supplemental Draft EIS (SDEIS) evaluates three reasonable alternatives for a US 550 connection based on whether they meet purpose and need requirements for highway improvements (capacity, safety and access), as well as cost and logistical factors.


The alternatives evaluated are: 1) Revised G Modified, the 2006 Record of Decision Preferred Alternative (with a slight alignment shift), which would realign US 550 to connect at the current interchange; 2) Revised F Modified, which connects at Three Springs Blvd.; and 3) Eastern Realignment, which also connects at Three Springs Blvd. (see attached map).

Alternatives not evaluated in detail in the SDEIS include a western realignment, and several alternatives utilizing the existing US 550 alignment and its current connection with US 160 (known locally as Farmington Hill). It was determined that these alternatives do not meet the purpose and need requirements (capacity, safety, access) or other screening criteria (cost, logistics). Additionally, a 'No Action' alternative was analyzed that would keep US 550 on its current alignment, where poor geometry, low design speeds and two-lane capacity on a north-facing steep grade presents both capacity and safety issues This alternative is evaluated in the SDEIS to provide a benchmark for comparison of the environmental impacts.

**The Final Step** - A Supplemental Draft Environmental Impact Statement (SDEIS) is complete. The document will be available to the public on October 14 followed by a 45-day public comment period. A public hearing will be held on November 2 at Escalante Middle School in Durango (5:00 to 8:00 PM). Following incorporation of public comments, a Final EIS will be prepared, and the Federal Highway Administration will produce a Record of Decision on a US 550/US 160 connection in the spring of 2012.

A Supplemental Draft EIS is now complete: this draft document identifies a US 550 alignment connecting at the US 160 interchange as the alternative that best meets safety, capacity and access requirements, and also has the least overall environmental impacts.

A public hearing will be held on November 2, from 6 P.M. to 8 P.M., at Escalante Middle School (141 Baker Lane in Durango). A 45-day public comment period, preparation of a Final EIS, and a Record of Decision by FHWA will be completed by spring 2012.
