At the last CSS Corridor Team meeting (Dec. 6th) we gathered hundreds of strategies on how to accomplish or protect our Core Values. The Project Team is currently sorting through these strategies and using them to begin some of the CSS Guidelines. During our discussions sustainability has come up as an overarching goal for the corridor. One current CSS effort is the formation of Working Groups. These groups will work on different elements of the CSS Guidance Manual.

One of these working groups is the Process Working Group, charged with developing specific methods that will ensure future decision processes are fair, equitable, open and collaborative. These methods will be included in the CSS Guidance Manual and will be used by all future planners, designers, and contractors.
