



Project Milestone I-25 Over Cimarron Street Girder Set Overnight Lane Closures and Restrictions Week of July 3, 2016

I-25 bridge work that spans the Cimarron/US 24 Interchange and upper Fountain Creek will require overnight road closures to set 30 girders. Each girder ranges in length from 72 to 132 feet and weighs up to 180,000 lbs. Setting Phase 1 girders is a milestone for the project team.

Full Overnight Closure on Cimarron Street / US 24

When: Tuesday, July 5, Wednesday, July 6, and Friday, July 8, 9 p.m. to 5 a.m.

What: Cimarron Street/US 24 closed

Where: On Cimarron Street/US 24 between the southbound I-25 and northbound I-25 ramps.


Why: To set Phase 1 girders for the new I-25 bridge crossing over Cimarron Street/US 24

Traffic Detour:

Westbound Cimarron Street/US 24 -detoured via northbound I-25 to Bijou Street, back to Cimarron Street/US 24

Eastbound Cimarron Street/US 24 - detoured via southbound I-25 to Nevada Avenue/Tejon Street, back to Cimarron Street/US 24

Overnight Closures - Southbound I-25 On- and Off-Ramps

When: Thursday, July 7, 9 p.m. to 5 a.m. and Saturday, July 9, 10 p.m. to 5 a.m.

What: Southbound I-25 on- and off-ramps closed


Where: Cimarron Street/US 24 will be closed between 8th and Sahwatch streets, including the southbound I-25 on and off-ramps

Why: Set Phase 1 girders for the new I-25 bridge crossing over Cimarron Street/US 24

Traffic Detour: Westbound detoured via Nevada Avenue, Colorado Avenue to Limit Street. Eastbound detoured via 8th Street, Colorado Avenue to Nevada Avenue

Northbound I-25 on-ramp remains open from westbound Cimarron Street and Northbound I-25 off-ramp will be open for right turn only.

Phase 1 Look-Ahead (more details available in weekly eAlerts) Sign up at www.cotrip.org, and then click on the bright green telephone. Scroll down to the "Projects" list for I-25 and Cimarron Interchange:

Various overnight lane restrictions and traffic realignments on I-25 and Cimarron Street/US 24 will continue to allow for removals, restriping and paving activities; to set barrier; shift traffic and for bridge construction. This phase is anticipated to continue through late winter 2016. Please keep in mind that all work is weather dependent and subject to change. Additional activities to expect in summer 2016:

July:

- Full overnight closure of westbound US 24 (8th Street to I-25) to shift westbound traffic onto new lane configuration west of I-25
- Overnight lane restrictions on northbound I-25 (Nevada Avenue/Tejon to Cimarron Street/US 24) and a full closure of the northbound I-25 off-ramp to Cimarron Street/US 24 to realign northbound I-25 off-ramp traffic
- Overnight closure of southbound I-25 off-ramp to Cimarron Street/US 24 for roadway realignment work

August:

- Full overnight closures on Cimarron Street (Sierra Madre to US 24) to set girders for the Cimarron over Fountain Creek bridge
- A full overnight closure of I-25 southbound off-ramp at Cimarron Street/US 24 to shift traffic onto permanent southbound I-25 off-ramp bridge
- Southbound I-25 closed between Cimarron Street/US 24 and Nevada Avenue/Tejon Street overnight to switch traffic out of split lane configuration, to the west

September:

- Various overnight lane restrictions on US 24 to shift permanent lane configuration west of the interchange

- Overnight lane restrictions southbound I-25 (Bijou Street to Nevada Avenue/Tejon Street) to switch traffic on to new pavement
- Overnight full closure of northbound I-25 (Bijou Street to Nevada Avenue/Tejon Street) to switch traffic on to new pavement

You Can Also Expect:

- Speed reduction to 55 mph on I-25 between Colorado Avenue and south Nevada/Tejon Street and 30 mph speed reduction on US 24 between 8th Street and I-25
- Narrowed lanes and reduced shoulders
- Three lanes maintained northbound and southbound I-25 during the day
