Police make arrest in child abuse case

A short time after 5 p.m. on Sept. 7, Lakewood police and paramedics from West Metro Fire responded to a report that a child was not breathing at an apartment in the 700 block of South Vance St.

At the apartment was a 2-year-old female who was immediately taken to a local hospital. Also in the apartment was 24-year-old Keith Nick Ruiz, believed to be the boyfriend of the child's mother. The mother was not at the apartment when the police arrived, but appeared soon after. The child is still hospitalized and being treated for possibly life-threatening injuries that police believe were caused by non-accidental trauma.

It was discovered that the child and Ruiz were the only two in the apartment before police were called, and as a result, Lakewood detectives have arrested Ruiz on charges of child abuse resulting in serious bodily injury. Ruiz was in advisement on Sept. 9 and is in custody at jail.

Sherman resigns as West Chamber president

Lakewood looking for volunteers

Board of Appeals – This board decides appeals of any type made by the codes administrator. Those interested must have experience and training to rule on issues involving building construction. The deadline for applicants is Sept. 23.

Planning Commission – The commission that holds public hear-

ings on rezoning and subdivision applications. It approves specific special-use permits and also reviews site plans. The commission meets on the first and third Wednesday of every month, at 7 p.m. The deadline for applicants is Sept. 23.

Victim Assistance Compensation Board – This board examines requests for compensation from crime victims and makes sure that crime victim funds are properly used. The board meets on the third Thursday of the month at 8 p.m. The deadline for applicants is Sept. 23.


FasTracks Citizens Advisory Committee coming to Lakewood
