Resolutions of Support

During the EA public comment period, resolutions of support for Interstate 25 improvements were received from local governments and other interested parties in the Pikes Peak Region. Copies of these resolutions are provided in this Appendix.

Local Government Resolutions

Resolutions of support for I-25 improvements were received from the following decision-making boards of elected officials:

- The Board of Directors of the Pikes Peak Area Council of Governments
- The Board of County Commissioners of El Paso County
- The Colorado Springs City Council.

Additional information about these resolutions is provided below.

PPACG

On April 14, 2004, a resolution of support for the proposed I-25 improvements was approved unanimously by the Board of Directors of the Pikes Peak Area Council of Governments (PPACG), which is the designated Metropolitan Planning Organization for the Pikes Peak Region. As noted in their resolution, PPACG acts to meet the transportation planning and programming requirements of Title 23 and Title 49, United States Code, and to formulate policies, plans and programs necessary to the planning process for transportation, land use, and air quality management.

The PPACG Board of Directors is composed of elected officials representing the region's three counties, six cities and six towns. Ex-officio (nonvoting) members include representatives of the Colorado Transportation Commission, Colorado Air Quality Control Commission, and the local public transportation (transit) community.

El Paso County

On April 12, 2004, a resolution of support for the proposed I-25 improvements was approved unanimously by the Board of County Commissioners of El Paso County. All transportation improvements comprising the Proposed Action in the I-25 EA are located within El Paso County, including both incorporated areas (such as the City of Colorado Springs) and unincorporated areas.

City of Colorado Springs

On April 27, 2004, a resolution of support for the proposed I-25 improvements was approved unanimously by the Colorado Springs City Council. The City of Colorado Springs is the largest city in El Paso County, accounting for approximately 70% of El Paso County's population.

The City Council resolution noted that the proposed improvements are consistent with the City's Intermodal Transportation Plan and the PPACG 2025 Long-Range Regional Transportation Plan. The resolution also urged CDOT to use available material, methods and practices that will provide the highest and best mitigation of negative impacts, including noise impacts. This statement is addressed in Section 4 of this NEPA decision document.

Non-Governmental Resolutions

Resolutions of Support for the proposed I-25 improvements were also received from the following community groups:
