

1.0 Introduction

CDOT is dedicated to providing an accessible experience for everyone. The Federal Highway Administration (FHWA) and Colorado Department of Transportation (CDOT) are preparing an Environmental Impact Statement (EIS) to evaluate potential improvements to the Interstate 270 (I-270) corridor. FHWA and CDOT are the lead agencies for this National Environmental Policy Act (NEPA) process, which was initiated in 2020, initially anticipating an Environmental Assessment (EA). Moving into 2023, CDOT determined a more detailed environmental review was needed and requested that an EIS be prepared.

This technical report documents the public and agency involvement that was completed as part of the project, including various outreach methods used, input received, and plans moving forward.

1.1 Project Description

I-270 in Colorado is a controlled-access interstate highway with two through lanes in each direction between Interstate 25 (I-25) and Interstate 70 (I-70) in central City and County of Denver (Denver) and City of Commerce City (Commerce City) (Figure 1). It has a posted speed limit of 55 miles per hour (mph). The project limits include the I-270 interchanges with Interstate 76 (I-76), York Street, Vasquez Boulevard, and Quebec Street. The project will tie into the I-25 and I-70 system interchanges but improvements to these interchanges are part of projects on I-25 and I-70 and will be designed and approved separately.

The purpose of the I-270 Corridor Improvements Project is to implement transportation solutions that modernize the I-270 Corridor to accommodate existing and forecasted transportation demands. The project needs are:

- Traveler safety on the corridor,
- Travel time and reliability on the corridor,
- Transit on the corridor,
- Bicycle and pedestrian connectivity across I-270, and
- Freight operations on the corridor.

In addition to addressing project needs, CDOT, FHWA, and Cooperating and Participating Agencies have established a key project goal: to minimize environmental and community impacts resulting from the project.

2.0 Public Involvement Introduction

Per the CDOT NEPA Manual, "Public involvement is a process by which the influence of various stakeholders is organized in relationship to decision-making. Public involvement acknowledges people's desire to participate in decisions that they perceive or actually will affect them." (CDOT, 2024, p. 7-1, 7-4).

2.1 Public Involvement: A Cornerstone of Project Success

Public involvement was more than a requirement; it was a strategic partnership between agencies and communities. By fostering open dialogue, shared decision-making, and mutual



respect, public involvement transformed projects from agency-driven initiatives into community-supported endeavors. This collaborative process ensured that projects aligned with community needs, addressed local concerns, and built lasting legacies.

To achieve these goals, public involvement required a structured approach that integrated the public's input into the decision-making process throughout the project lifecycle. This involved actively engaging stakeholders to gather multiple perspectives, values, and knowledge. By fostering open communication and trust, public involvement enhanced the project development process, leading to more informed, accepted, and sustainable outcomes.

Effective public involvement went beyond meeting regulatory requirements; it empowered communities, informed decision-making, and built trust. By incorporating multiple perspectives, agencies created projects that were not only feasible but also desired by the community. This process involved actively listening to public input, addressing concerns, and making informed decisions that considered economic, environmental, and social factors. By incorporating community perspectives, agencies identified and addressed potential impacts, balanced competing interests, and made informed decisions. Ultimately, public involvement strengthened the relationship between agencies and the communities they served, leading to projects that were more likely to be accepted and supported.

2.2 I-270 Public Involvement Mission

The overall mission of public involvement for the I-270 Corridor Improvements EIS was to create an atmosphere of openness and trust with the public. Community input was vital to the project's success, and the project team was committed to providing meaningful public involvement opportunities throughout the process.

2.2.1 I-270 Public Involvement Goals and Principles

Robust public and stakeholder involvement was critical for the success of the project. The I-270 corridor runs through communities, mixing industrial and residential uses. Enhanced public input and participation at all points of the EIS process ensured meaningful participation. Information related to additional public involvement processes required by Colorado Senate Bill 21-260 are provided in a separate report that is available on the project website (https://www.codot.gov/projects/studies/i270study). The public involvement effort is intended to establish and maintain a two-way exchange of information and ideas between the public and the project team regarding corridor issues and priorities.

Public involvement goals for the EIS included:

- Conducting an extensive public outreach effort to gather input from users of the corridor as well as the populations along the project area;
- Ensuring meaningful public participation for all stakeholders;
- Using a grassroots approach, such as setting up tables in front of common communitygathering places to provide project information for neighborhoods directly affected by I-270:
- Informing the public about work in process and continually monitoring community concerns;



- Providing information in a manner that is easy for the public to access and understand;
- Educating the public on the study and the EIS process;
- Working with local businesses, chambers of commerce, community groups, and other organizations to obtain comments from a broad cross-section along the corridor; and
- Ensuring the federal, state, regional, and interested local government agencies are well informed at every stage.

The overall objective of all outreach activities was to ensure that the community had meaningful input into the study, and that the project reflected community input and values. Based on the identified public involvement goals, several principles were developed as the foundation for the public involvement program.

These principles included:

- Facilitating early involvement by public stakeholders in identifying corridor issues and opportunities;
- Building an understanding of the project and transparency for the EIS process;
- Establishing and maintaining productive partnerships with individuals and organizations that are interested in the project;
- Providing project information in English and Spanish, and using a bilingual community liaison to help plan and conduct community outreach;
- Providing additional services at corridor-wide meetings (e.g., meeting locations near transit routes, centrally located venues, American Sign Language (ASL) interpretation, Spanish translation, childcare, services for hearing and visually impaired, as requested), so that residents can participate in the process;
- Using local vendors for reproduction, catering, childcare, and other services as much as possible;
- Being aware of the need to provide information and gather public input in a variety of ways;
- Providing information to the media proactively;
- Maintaining a project record that clearly tracks the public input into the decisionmaking process; and
- Providing remote meeting opportunities, scheduled calls, or telephone town halls.

These principles supported the goals of the plan and ensured that the EIS process served the public interest.

2.2.2 Language Assistance

Within the Community Study Area, Spanish-speaking populations were notably high—with Commerce City at 46.8 percent, Welby at 34.5 percent, and North Washington at 48.7 percent. No other languages were prevalent in more than 4 percent of the Census block groups. As a result of the demographic information on language use in the study area and in consultation with CDOT and FHWA, Spanish translations were determined to be necessary for the I-270 corridor project. Additionally, ASL services were recommended and included for public meetings and webinars.



3.0 Community Outreach 2020-2022

CDOT and FHWA began a NEPA process in 2020, initially anticipating an EA. While virtual engagement during the EA process between 2020 and 2022 provided valuable input, constraints of the COVID-19 pandemic limited the potential of outreach. Moving into 2023, CDOT determined a more detailed environmental review was needed and requested that an EIS be prepared. Through the EIS, CDOT committed to expand outreach efforts and strengthen community relationships through increased public participation.

A summary of the public outreach techniques used during the initial period from 2020 to 2022 is listed below:

- Hosted a bus tour through the corridor for stakeholders and elected officials that included Spanish translation;
- Conducted two virtual public meetings (August 17-30, 2020, and December 2-27, 2020);
- Attended small group meetings with businesses and other stakeholders;
- Developed and updated a project website;
- Utilized CDOT's social media platforms;
- Commerce City posted to NextDoor on December 2, 2020;
- Sent media releases and involved media in a proactive manner;
- Met with local and state elected officials as well as advocacy groups:
- Used flyers to notify residences and businesses of virtual meetings and project updates;
- Sent email updates to I-270 project subscribers;
- In July 2020, more than 7,000 direct mail postcards were sent to residents in zip codes 80022, 80216, and 80238; and
- In November 2020, close to 18,000 direct mail postcards were sent to residents in zip codes 80022, 80029, 80216, 80238, and 80221.

3.1 Summary of Public Comments Received during the Virtual Meetings

3.1.1 August 17-30, 2020, Meeting Period Summary

Concerns and suggestions emerged about the I-270 corridor in metro Denver. Participants highlighted severe traffic issues, particularly at the Vasquez Boulevard interchange, which suffers from congestion and safety hazards due to outdated ramp designs and tight merge areas. There was a strong consensus on the need to expand the highway to three or four lanes in each direction, improve ramp geometries, and enhance truck management. Suggestions included extending Express or high occupancy vehicle lanes, avoiding tolls, and improving infrastructure for better traffic flow and safety. Environmental impacts, especially concerning Sand Creek and the Sand Creek Greenway, were also discussed—with calls for mitigation and improved visual appeal. Additionally, there was an emphasis about better pedestrian and bicycle facilities, improved local road connectivity, and effective community engagement to address current needs and future growth.



3.1.2 December 2-27, 2020, Meeting Period Summary

There was a debate about proposed improvements to the I-270 corridor. Many attendees supported adding general-purpose lanes in each direction to address severe congestion, particularly around the Vasquez Boulevard interchange, citing the existing issues with merging lanes and heavy truck traffic. While some favored Express Lanes, others opposed them due to concerns about tolls, environmental impacts, and potential misuse. Participants also recommended redesigning key interchanges, extending the merging lanes, and improving bicycle and pedestrian access. There were calls for a comprehensive approach that balances lane expansions with alternative solutions, such as enhanced mass transit and infrastructure repairs to ensure long-term effectiveness and community well-being.

4.0 Public Involvement Plan Execution (2023-Present)

A Public Involvement Plan (PIP) was developed and implemented when the EIS was initiated in 2023. Summaries of the activities conducted are provided in this report.

To maximize public engagement, the project team employed a range of outreach methods tailored to different community groups. The I-270 EIS outreach process utilized innovative strategies and commonly used tools to encourage widespread participation.

4.1 Public Involvement Plan

The PIP was developed and implemented to achieve expanded outreach goals and guide the EIS process. The PIP is available on the project website (https://www.codot.gov/projects/studies/i270study/noticeofintent). The PIP laid out the lead agencies' approach for providing information to and receiving input from the general

The PIP outlined objectives, goals, and principles to meet this mission. PIP objectives included identifying interested stakeholders; providing various forums and mechanisms for distributing information; ensuring meaningful opportunities for public participation from communities; encouraging and soliciting comments on all aspects of the process, well before key decision points; incorporating comments/feedback received into the process and key decisions; and ensuring compliance with NEPA and relevant regulations.

4.2 Meaningful Participation and Enhanced Engagement in the Community Study Area

The PIP was developed as a flexible document that was adapted based on the project and public needs and effective approaches to public involvement. The community study area was developed based on Census block groups within one mile of the project area. Outreach techniques for local communities were informed by best practices and recommendations from



CDOT, the Colorado Department of Public Health and Environment (CDPHE), the U.S. Environmental Protection Agency (EPA), and direct community input.

Due to the large percentage of Spanish speakers in the project area and requests from community organizations, FHWA and CDOT developed an Outreach Plan (CDOT, 2023). The purpose was to generate interest in the project and engage residents in the project area along with influential community leaders, organizations, and other agencies.

Strategies of the Outreach Plan included:

- Hosting in-person stakeholder workshops attended by identified stakeholders and those who expressed interest in participating.
- Developing and continually updating a list of monthly community events and festivals, Registered Neighborhood Organization (RNO) meetings, volunteer opportunities, and project tours to gather community feedback and distribute educational materials to community members.
- Attending and engaging with residents and businesses at community events, offering Spanish interpretation to gather feedback from Spanish-speaking community members.
- Providing educational materials in local newspapers, magazines, church bulletins, and Facebook and WhatsApp groups.
- Identifying volunteer opportunities to help integrate the project team into the community.

CDOT's intentional efforts to engage local populations are reflected in the scope of outreach approaches, information dissemination methods, and public input opportunities. These methods and approaches have been adapted and expanded over the course of the I-270 project development to focus on project awareness through in-person engagement at community events and sustained involvement through regular stakeholder workshops to ensure affected community members are represented and engaged in the project and have a voice with other decision makers in providing authentic and meaningful community input to support the project development.

4.3 Project Website

The project website (https://www.codot.gov/projects/studies/i270study) provided a comprehensive resource for information and updates on the I-270 project. It included an "About the Project" section that outlined the project's background, goals, and the purpose and need for improvements. A calendar highlighting community engagement opportunities, including events where the project team would be attending was posted. The website also offered a feedback form where community members could share their input and ask questions, along with contact information for reaching the project team directly. Links to related projects and studies and the Notice of Intent (NOI) to prepare an EIS and supporting NOI information were provided to give context and additional background. A gallery of photos offered a visual overview of the project area and progress, and a link to stay informed and connected allows visitors to sign up for updates and announcements. Additionally, the website included summary information on past and ongoing community outreach efforts to demonstrate how public feedback has shaped the project. Frequently Asked Questions (FAQs) for the I-270 project provided essential information about the EIS process, including its



purpose, the need for highway improvements, and various alternatives under consideration. They explained differences between general-purpose and Express lanes, addressed critical bridge repairs, outlined strategies for engaging with the community, and collected input.

4.4 Comment Forms

Comment forms were distributed at public and community meeting in both English and Spanish, and all meeting materials are provided in these languages. Online comment forms were also available as a convenient way for the public to share feedback on specific project aspects, without attending a meeting.

General comments or questions could also be submitted at any time via e-mail and were accepted through the project website. Input received through email or online comments (outside of specific events) included comments emphasizing the urgency for additional lanes on I-270, citing existing issues, such as severe potholes, poorly designed ramps causing traffic jams, and dangerous backups. Some feedback also criticized recent improvements focusing on repairs rather than increasing lane capacity and inquiries about potential right-of-way acquisitions and the project timeline.

The project team reviewed all submitted comments. All feedback was considered and incorporated into the project, as appropriate. Comments received during the scoping period from 2020-2023 are summarized in the Scoping Summary Report (Attachment A) as well as the comments received during the NOI comment period.

4.5 Public Meetings

CDOT hosted three rounds of public meetings as part of the Draft EIS process. In-person meetings occurred at Eagle Point Recreation Center, and the virtual meetings occurred on Zoom. 4.5.1 Public Meeting #1 - October 2023

Public meeting 1 occurred as a scoping meeting that introduced the EIS process and educated the public about the project purpose and need and the history of the corridor, along with preliminary proposed alternatives.

4.5.2 Summary of Public Comments

The I-270 Corridor Improvements Project aims to modernize the corridor and to meet current and future transportation needs, focusing on traveler safety, transit options, bicycle and pedestrian connectivity, travel time reliability, and freight mobility while minimizing environmental impacts. Community feedback highlighted the concerns about increased traffic, air quality, and safety; with suggestions for adding lanes; improving bike and



pedestrian infrastructure; and enhancing transit options. There were strong preferences included adding three general-purpose lanes with an Express Lane and improved environmental and aesthetic features. There was also strong support for better communication with surrounding communities, and addressing current issues, such as potholes and traffic congestion.

4.5.3 Public Meeting #2 - April 2024

Public meeting 2 focused on reviewing a variety of potential project alternatives, including proposed improvements for bicyclists, pedestrians, and transit. The project team developed and assessed several alternatives based on the project purpose and need. Valuable community input helped refine the project alternatives and expand the range of options considered.

4.6 Summary of Public Comments

At the round of meetings, more than 70 percent of attendees engaged actively, with many providing comments and expressing interest in further involvement. Discussions revealed strong support for the I-270 corridor project, highlighting its necessity and overdue nature, especially given the perceived neglect of the area compared to other parts of Denver. Participants offered thorough feedback on project alternatives by emphasizing the need for lane expansions and improvements, including specific suggestions for Express Lane operations, environmental enhancements, and better public outreach. Notably, these comments focused on the effectiveness of proposed alternatives—with varying opinions, including additional lanes, Express Lanes, or bicycle/pedestrian improvements. Specific location-based recommendations were also provided, including improvements to interchanges and considerations for bicycle and pedestrian facilities. Overall, the feedback underscored a broad interest in ensuring the project addresses traffic issues, incorporates community needs, and enhances the corridor's environmental and aesthetic qualities.

4.7 Public Meeting #3 - January/February 2025

Information about the various design improvements under consideration was presented, and participants were asked to share input about the alternatives they felt should be moved forward, any concerns they might have for the I-270 project, how to improve outreach, and how to enhance environmental or community resources.

4.8 Summary of Public Comments

At both in-person meetings, attendees talked with project staff and other attendees about the project and how they could get involved. The attendees were engaged, and many filled out comment forms and/or left comments on post-it notes on the roll plot. Attendees also had questions about the construction process and the project's timeline. Many offered opinions on their preferred alternative moving forward and additional elements that could or should be considered.

Comment cards revealed strong community support for advancing the I-270 project, with many attendees emphasizing that improvements are long overdue and would benefit both Commerce City and interstate users. Attendees frequently cited the corridor's current state as dangerous, congested, and visually unappealing. While no comments expressed direct opposition, there were several concerns and suggestions. Air quality emerged as the most pressing environmental issue, while safety and congestion were identified as the primary concerns overall. Participants also expressed interest in protecting or enhancing environmental resources, like water and green space, increasing public transit options, and gaining a clearer understanding of project funding. Some concerns were raised about Express Lanes and tolling, noise walls potentially blocking business visibility, and design details at specific locations.

4.9 Events and Festivals

During the summer of 2024, the project team participated in a variety of local events, including sporting events, festivals, and farmers markets. These events provided the opportunities to distribute project information, answer questions, and gather input from community members.

In addition to engaging with a large number of residents, these events helped the team expand the project's community network and gain a deeper understanding of the organizations and interests present in the project area. Table 2 provides a detailed list of the events and festivals attended by the project team.

4.11 Community Office Hours

Community office hours were designated periods, where project representatives were present within a community to provide information and address questions or concerns about a project. The goal of community office hours was to foster open communication, build trust, and ensure that the public felt informed and involved in the project.

4.12 Listening Sessions

A community listening session was a gathering where attendees shared their thoughts, opinions, and concerns about a specific topic or project. These sessions were open and took place at popular community destinations, allowing participants to express themselves freely.

In the context of the I-270 project, these listening sessions directly engaged residents to gather their feedback on the proposed improvements (see Table 4). These sessions were hosted in community locations and included Spanish-speaking staff.

4.13 Stakeholder Workshops

In March 2024, CDOT began hosting stakeholder workshops to better understand community concerns and to gather input on the project, proposed alternatives, and potential environmental impacts and mitigation measures. Initially designed to explore the community context and vision, these workshops have evolved into a collaborative forum for an open, respectful debate and discussion about transportation and community values, directly shaping the project development.

The workshops brought together a mixed group of participants, including residents, businesses, and representatives from local service and environmental organizations, alongside decision makers and other agencies working in the project area, including CDOT. Suggested by environmental organizations, the workshops were intentionally set up to allow for discussions on multiple disciplines, incorporating perspectives from community leaders, local



businesses, transportation providers, and other stakeholders familiar with the area and its unique challenges.

The workshops were facilitated and conducted in both English and Spanish. Each session included a blend of educational components, such as guest experts and background information, and collaborative discussions to address project and community concerns. Workshop topics were developed collaboratively by participants, focusing on key issues of greatest interest (Table 5 summarizes the stakeholder workshop topics).

These regular workshops fostered consistent engagement, allowing participants to build on prior discussions and develop a deeper understanding of the project's context and potential impacts. They were instrumental in defining the scope of the EIS, identifying critical issues, and building community understanding. The workshops continued throughout 2024 and 2025.

4.14 Business Outreach and Interviews

CDOT conducted business interviews to collect insights on how the I-270 corridor impacts local industries and commerce, as well as identifying potential improvements for the movement of goods and services. Outreach focused on businesses located near I-270 and regional industries reliant on the corridor, such as Denver International Airport. Interviews targeted a range of sectors, including retail, manufacturing, and healthcare. Organizations involved included:

The outreach process, which incorporated input from subject matter experts, used tailored survey questions and was conducted through in-person meetings, virtual sessions, and online methods.



Businesses provided valuable feedback on how I-270 impacts their operations, customers, and employees. These interviews were conducted by the CDOT project manager and/or design manager, along with representatives from NETC, a transportation management association serving the project area.

CDOT also hosted business breakfasts and a business open house, with a focus on businesses in the project area.



4.15 Freight Industry and Trucking Industry Outreach

Engagement with the freight and trucking industry was a key component of the project, as freight operations along the corridor were identified as an important transportation need. Industry representatives and local trucking operators have consistently participated in stakeholder workshops, providing valuable input on operational challenges and needs. The team has also coordinated closely with CDOT's freight mobility branch and participated with the FAC to share project information and gather feedback.

4.16 Volunteer Opportunities

In addition to traditional stakeholder engagement, the I-270 project actively engages with the community through volunteer events. These efforts help the team better understand community issues while keeping the public informed about the project's progress, potential impacts, and benefits.

Volunteer events further strengthen community relationships. By supporting local causes, collaborating with non-profits, and contributing to community development, the project team has gained valuable insights into the well-being of areas affected by highway improvements. These initiatives create opportunities to partner with community organizations, encourage active public participation, and gather meaningful feedback. This engagement broadens the project team's understanding of interconnectedness of community issues and needs, helping inform decisions and leverage shared interests to achieve better outcomes for the community. 4.17 Agency Coordination

Interagency coordination is a fundamental component of the NEPA process, and formal designation of agency roles and responsibilities is specifically required for an EIS. Roles and responsibilities for agencies involved in the EIS process are described in 23 CFR Part 771 Environmental Impact and Related Procedures and 23 U.S.C. 139: Efficient Environmental Reviews for Project Decision Making and One Federal Decision. FHWA and CDOT are the lead agencies for this EIS, and 16 other agencies are involved as cooperating or participating agencies in the process. They include:

The I-270 Improvements Project Agency Coordination Plan (updated July 2024 and available on the project website: https://www.codot.gov/projects/studies/i270study/noticeofintent) identifies the agencies involved in the EIS, outlines agencies' roles and responsibilities, describes the project schedule and agency coordination points, defines permitting requirements and timelines, and describes the methods and principles for agency and public engagement.

As described in the Agency Coordination Plan, FHWA and CDOT provided regular project updates to agencies throughout the EIS process. The agencies, in turn, shared updates, new data, and/or stakeholder feedback related to their area of expertise or jurisdiction that could affect the project or the lead agencies' decision-making. The lead agencies determined the best mode of communication for quarterly updates.

CDOT and FHWA also held interagency working group meetings with EPA regarding air quality analysis and local agency coordination meetings with Adams County and Commerce City. In addition, the lead agencies coordinated with numerous agencies on an individual basis, including Mile High Flood District, Colorado State Historic Preservation Office, CPW, USFWS, CDPHE, Denver Regional Council of Governments (DRCOG), and Denver.

Commerce City, Adams County, RTD, DRCOG, and local emergency service providers also participated in the stakeholder working group, and many agency staff coordinated with the lead agencies on specific topics outside of the primary coordination meetings.
