Location: US 160 Elmore's Corner to Dry Creek Design-Build

Request for Letters of Interest for **Design-Build Services** US 160 Elmore's Corner to Dry Creek Project

The Colorado Department of Transportation (CDOT), Region 5 is soliciting Non-Mandatory Letters of Interest (LOI) from companies or teams interested in providing Design-Build (D-B) Services to widen US 160 from Elmore's Corner (SH 172) to Dry Creek (west of County Road (CR) 223), east of Durango, Colorado.

The purpose of this project is to widen US 160 from Elmore's Corner to CR225, expanding the roadway to four lanes with a center two-way left turn lane and widened shoulders. The project includes safety improvements at the CR225 intersection to reduce the frequency and severity of accidents. From CR225 to Dry Creek, the project scope includes construction of at least one mile of passing lane in each direction and widened shoulders. Additional major elements include two large mammal underpasses and the replacement of the Florida River Bridge. The work will establish new US 160 typical sections and all associated improvements required to deliver a fully functioning and resilient facility. CDOT has executed an Environmental Impact Statement (EIS) for the corridor and a reevaluation for the interim improvement of the corridor has been approved.

The anticipated construction cost for this project is in the range of \$65-\$75M.

CDOT has determined that Design-Build is the most effective delivery method to maximize the benefits of this project. This approach will provide the flexibility and innovation needed to manage risk effectively while also supporting the project's grant funding timelines.

The non-prioritized goals for this project include the following. The Project goals will continue to be refined along with the development of the RFP and may be altered, reduced, or added to prior to the issuance of the RFP.

- Improved Safety, Mobility, and Efficiency
- Minimized impacts to highway users
- Effective partnerships
- Excellence in project delivery

A Request for Proposals (RFP) will be sent to those teams. Proposals will be evaluated using best-value criteria. The RFP will include a conceptual design and will encourage innovation from the proposers.
