



COLORADO PEACE OFFICER STANDARDS AND TRAINING TRAINING ANNOUNCEMENT

Through tax revenue generated from the legalization of marijuana, POST is providing several Advanced Roadside Impaired Driving Expert (ARIDE) and Drug Recognition Expert (DRE) courses State-wide through June 2015.

ALL ARIDE CLASSES ARE OPEN TO ALL LAW ENFORCEMENT INCLUDING CAMP GEORGE WEST (GOLDEN). OFFICERS ARE NOT LIMITED TO ATTENDING COURSES HELD IN THEIR TRAINING REGION.

ARIDE Training - The Advanced Roadside Impaired Driving Enforcement (ARIDE) program was created to address the gap in training between the Standardized Field Sobriety Testing (SFST) and the Drug Evaluation and Classification (DEC) Program.
